#### Significant Issues:

#### 2020 December Southeast Storm Disaster:

Pursuant to Governor Dunleavy's declaration, disaster Individual Assistance and Temporary Housing operations are ongoing. To date over 100 Individual Assistance registrations have been received from nine different communities in Southeast and verification teams have been deployed in the declared disaster area to support implementation.

In coordination with the Haines Emergency Operations Center, Alaska Department of Transportation and Public Facilities, and the Alaska Division of Geophysical and Geologic Surveys, work continues to provide an assessment of the stability and further risk in the Beach Road slide area.

#### **Tuluksak Washeteria Fire:**

The SEOC continues to be in contact with the community of Tuluksak as well as multiple state, federal and tribal organizations in support of both the short and long-term recovery efforts for the community.

#### Coronavirus (COVID-19) Pandemic:

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.

DHSS is operating as the Medical Branch under the State EOC/Unified Command.



#### Significant Weather:



A Blizzard Warning is in effect for St. Lawrence Island and the Bering Strait Coast until 3:00 P.M. today. Additional snow accumulations of up to 3 inches are expected along with winds gusting as high as 65 mph.

A Winter Storm Watch has been issued for Juneau, Douglas, Petersburg, Wrangell, Hoonah, Gustavus, and Tenakee Springs. Beginning late today through 3:00 P.M. Thursday, heavy snow is possible with total accumulations of 5 to 11 inches possible.

A Winter Weather Advisory is in effect for the Kuskokwim Delta and Bristol Bay until 3:00 P.M. today. Snow and sleet is expected with total accumulations of 4 to 10 inches across the area.

The majority of the state continues to be under either a wind chill advisory or warning through this afternoon. Wind chills of up to 65° below zero are possible in some areas across the state.
