Significant Issues:

Selawik Power Outage:

Full electrical power is available in the community and power conservation measures are no longer needed. The Alaska Native Tribal Health Consortium completed the installation of a watering point yesterday and collected a water sample for testing. DEC has confirmed that they lifted the boil water notice for the community.

Unalakleet Water Issues:

The SEOC will be deploying an Emergency Management Specialist today to serve as the Unalakleet Division Supervisor for the SEOC to support the response and recovery efforts that are underway for the community. The SEOC is in regular contact with community leadership to address any immediate needs.

Coronavirus (COVID-19) Pandemic:

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.

State of Alaska Department of Health and Social Services (DHSS)

DHSS is operating as the Medical Branch under the State EOC/Unified Command.



Blizzard Warnings are in effect for St. Lawrence Island, Bering Strait Coast, Chukchi Sea Coast, Baldwin Peninsula, Selawik Valley, Kuskokwim Delta Coast and the Western Arctic Coast until 11:00 P.M. tonight.

A Winter Storm Warning remains in effect for the Yukon Delta through 9:00 P.M. tonight.

Winter Weather Advisories remain in effect for Kodiak Island, Seward Peninsula, Eastern Norton Sound, Nualato Hills, Lower Yukon Valley, Bristol Bay, Denali, Eastern Alaska Range and the Northeastern Brooks Range through Saturday morning.

A Special Weather Statement is in effect for snow and blowing snow across the Western Kenai Peninsula from Friday morning through Saturday morning.
