### **Selawik Power Outage:**

Full electrical power is available in the community and power conservation measures are no longer needed. Potable water is available in the community. Some water and sewer mains and individual service lines remain frozen. The SEOC is in regular contact with community leadership to address any immediate needs.

#### **Unalakleet Water Issues:**

Yesterday the SEOC deployed an Emergency Management Specialist to serve as the Unalakleet Division Supervisor for the SEOC to support the response and recovery efforts that are underway for the community. The SEOC is in regular contact with community leadership to address any immediate needs.

## Coronavirus (COVID-19) Pandemic:

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.
