Significant Weather:



A Flood Advisory remains in effect through this evening for the Kennicott River near McCarthy. The Hidden Lake dam has begun to release and will cause a significant rise in the river. Water levels are expected to rise 2 to 5 feet over the next 24 to 48hrs. The Chitina and Copper Rivers will experience moderate rises in water levels as the glacier dammed outburst continues downstream.
