

Significant Weather:



The following weather watches, warnings, or advisories have been issued:

- A Coastal Flood Watch has been issued for the Northern and Western Arctic Coast, Chukchi Sea Coast and Baldwin Peninsula from Wednesday night through Friday morning. Water levels are expected to rise 3 to 8 feet above the normal high tide line across the region during this event and significant erosion is possible.
- A High Wind watch has been issued for the following areas:
 - Western Arctic Coast and the Chukchi Sea Coast Wednesday afternoon through Thursday evening. South winds 30 to 40 mph with gusts to 65mph.
 - St. Lawrence Island and the Bering Strait Coast Wednesday afternoon through Wednesday evening. South winds 30 to 40 mph with gusts to 60mph.
 - Northwestern Brooks Range Wednesday evening through Thursday afternoon. South winds 25 to 35 mph with gusts to 65mph.
- A Special Weather Statement remains in effect for Norton Sound, the Seward Peninsula Coast, St. Lawrence Island and the Bering Strait Coast. A storm will bring the potential for high surf and erosion to south and west facing shores from the Bering Strait to Norton Sound Wednesday night through Friday. In addition, elevated water levels bring the potential for minor coastal flooding to low lying areas in Northern Norton Sound, and to Deering on the northern Seward Peninsula.
