Significant Issues:

<u>Unalaska Heavy Rainfall</u>

Yesterday Unalaska Public Safety informed the SEOC that they were standing up their EOC due to heavy rainfall. The rainfall caused two local roads to be closed as well as low-lying flooding and high water in local streams and lakes. SEOC reached out the National Weather Service who indicated that an additional 5.55 inches of rain is expected through Thursday evening. Late last night the Unalaska EOC advised the SEOC that they would be keeping their EOC open over night in a warm status to monitor conditions.

Metlakatla Power Outage

The SEOC was contacted yesterday by the community of Metlakatla regarding a community wide power outage due to failure of their backup generator and an increased demand on the primary system due to cold weather. The community reports the school and the clinic are running on their own separate backup generators to lighten the load on the community electrical system. SEOC contacted the Alaska Energy Authority (AEA) to offer technical assistance to the community.

Crooked Creek Power Outage

The SEOC was notified yesterday of additional power outages/distribution issues in Crooked Creek. SEOC contacted AEA who is working in partnership with the Middle Kuskokwim Electric Coop to get a line crew to the community today to address the electrical balancing issues.

Significant Weather:



Flood warning for the Eastern Aleutians in effect until 1145am Friday due to excessive rainfall causing flooding in small streams and low-lying areas.

Winter storm watch in effect for Eastern Beaufort Sea Coast for 1 to 3 inches of snow and winds of 50mph causing blizzard conditions.

Wind chill advisory in effect for the Upper Koyukuk Valley until 3pm this afternoon for wind chills as low as 50 degrees below zero.

Wind chill advisory in effect for the Kuskokwim Delta until 11am for wind chills as low as 45 degrees below zero.

Winter weather advisory remains in effect for the City and Borough of Yakutat noon today for 4 to 6 inches of snow.

Wind chill advisory remains in effect for the Municipality of Skagway until noon today for wind chill temperatures as low as 30 degrees below zero.

Wind chill advisory remains in effect for the Deltana Upper Tanana Valley and Tanana Flats through this afternoon for wind chill temperatures as low as 55 degrees below zero.

Special weather statements are in effect for the Southeast Panhandle for extreme cold temperatures through Wednesday. A shift from colder temperatures is expected to bring heavy snowfall starting in the Southern Panhandle late Thursday then move north Friday into Saturday. Current projections are for 6 to 12 inches of snow primarily Friday into Saturday.

Special weather statement in effect for the Western Kenai Peninsula for potential ice jam on the Kenai River from Kenai Keys to Soldotna into Wednesday.
