

## State Emergency Operations Center (SEOC) Activated to Level 2

## **Incident Overview**

On Monday, November 20<sup>th</sup> at 2051hrs the City and Borough of Wrangell experienced a major landslide at mile 11 of Zimovia Highway. The State Emergency Operations Center (SEOC) was notified of the landslide at 2130 hrs. on November 20<sup>th</sup>, recalled staff, activated to Level-2 and is coordinating multiple requests for state-level resources in support of Wrangell's Incident Command.

On November 21st, 2023, Alaska Governor Mike Dunleavy declared a state disaster emergency for the City and Borough of Wrangell. On November 26<sup>th</sup>, 2023, Governor Dunleavy also declared a state disaster for the City of Coffman Cove.

## **Significant Operations Updates**

#### **Wrangell City and Borough:**

Today the SEOC transitioned Division Supervisors, with existing supervisor returning to Anchorage. SEOC intends ongoing in-person on-ground SEOC Division Supervisor level support for the City and Borough of Wrangell until no longer needed. Wrangell Division Supervisor is engaged with City and Borough search, roadway, mass care, tribal coordination, Individual Assistance, and recovery support.

The Department of Public Safety (DPS), in coordination with the Wrangell Incident Command, continues to support a reactive search strategy for the missing victims. Yesterday search teams located and recovered a deceased adult male. Next of kin have been notified. One juvenile remains missing.

Two lanes of the Zimovia Highway have been opened by crews from the City and Borough of Wrangell and the Department of Transportation and Public Facilities (DOT&PF). The Wrangell Police Department is issuing permits to residents who are authorized to pass through the slide area. Openings are scheduled for 8:00 to 8:30 AM, 12:00 to 12:30 PM, and 3:30 to 4:00 PM. DOT&PF continues work around the slide area and has removed several hundred truckloads of debris from the slide area since beginning route clearance work. DOT&PF will deploy on-scene weather stations to provide real-time weather data for responder and crew safety around the slide.

Division of Geological and Geophysical Surveys (DGGS) successfully collected 12.5 square miles of data from Wrangell using a contracted lidar survey helicopter. DGGS estimates it will take at least one week to analyze the data. DGGS has demobilized their remaining personnel but will schedule a future briefing for the community once the data is analyzed.

A Red Cross 3-person Incident Care Condolence Team continues to support the community.

#### **Recovery Branch:**

The State Individual Assistance registration hotline and website opened on November 28<sup>th</sup>, and applications are being accepted from the state-declared areas.

State Public Assistance is providing the City and Borough of Wrangell and the City of Coffman Cove with technical advice on the disaster reimbursement process.

#### **Diomede Division:**

On Sunday, November 26<sup>th</sup>, the community reported that the city office building, constructed in 1978, had several wooden supports fail on one side of the structure. On Monday, remaining supports collapsed leaving the building on the ground, with the northwest corner resting on the community elementary school. Foundation damage resulted in the building being condemned, and demolition is planned.

The City and Tribe of Diomede have declared a local disaster emergency and SEOC Division Supervisor has been in multiple meetings with the community daily to provide response guidance, along with regional tribal authorities.

SEOC is deploying a DOT&PF structural engineer to Diomede, who will accompany the Bering Straits School District Facilities Director and a representative from Kawerak Inc. Due to weather the deployment of the engineer has been delayed until Sunday. DOT&PF engineer will assess the collapsed structure for hasty recovery of city/tribal property and evaluate the school for student attendance. \

Diomede's school is closed for in-person learning until the school structure is assessed, and Bering Straits School District has moved to online learning, with laptops being distributed to students. Remote learning will resume Monday.

The community post office, previously located in the collapsed building, was relocated to the old washeteria building to continue mail service and food deliveries via bypass mail.

Alaska Department of Environmental Conservation (DEC) advised they addressed water supply contamination concerns from a fuel leak at the collapsed building. The local water plant is not currently producing water due to the temperature, and no water contamination occurred. DEC is providing technical assistance to the Diomede water plant operator for routine testing to confirm water supply quality.

#### **Other Southeast Communities Group:**

**City of Craig:** On Tuesday, November 28, the SEOC was notified of damage caused by flooding and landslides across Prince of Wales Island. The City of Craig reported their public works department did emergency route clearance work across the island. While no injuries are reported, several homes are reporting damage. The City declared a local disaster emergency last night.

SEOC deployed a Group Supervisor to the Island yesterday to coordinate an initial assessment of damages and provide on-site response coordination. The Group Supervisor is meeting with the city as well as local utilities to discuss and document damage, both in cities and the Unorganized Borough communities.

**Wrangell:** The Wrangell Police Department is issuing permits to residents who are authorized to pass through the slide area to return to their residences. Openings are scheduled for 8:00 to 8:30 AM, 12:00 to 12:30 PM, and 3:30 to 4:00 PM.

**Diomede:** School has transitioned to online learning and is distributing laptops to students. DOT&PF engineer has been delayed due to weather, with revised arrival date of Sunday.

**Recovery Branch:** State Individual Assistance (IA) hotline and online IA application for residents of the declared area is open. IA has received 7 applications.



#### **Communications**



**Southeast:** The Notice to Mariners regarding US Coast Guard Channel-16 VHF communications in the Southeast-region remains in effect. USCG requests mariners relay all unanswered requests for assistance to the USCG including both radio and phone.

**Wrangell:** Residents continue to rely on deployed Starlink receivers for connectivity south of the slide area. Utilities are actively working to reestablish regular service.


