Recent Earthquakes

SEOC duty office contacted the City of Haines Police Department about two earthquakes that happed Friday October 27th. The City of Haines Police Department stated that there was no damages from these events. Both earthquakes were located 40 miles SW of Hanes, Alaska 90 miles NW of Juneau, Alaska at a depth of 1 mile. The first magnitude 4.9 happed at 7:05 PM, followed by a 7:47 PM magnitude 4.8. National Tsunami Warning Center did not issue any warning of these events.

Patchy Freezing Rain Possible in the following areas: Noatak Valley; Lower Kobuk Valley; Baldwin Peninsula; Lower Yukon River; Lower Koyukuk Valley; Middle Yukon Valley; Lower Yukon and Innoko Valleys. The next round of precipitation is expected to begin on Monday and end on Tuesday. Precipitation type will vary by location, with warmer areas near the coast more likely to see rain. Sheltered inland areas that stay below freezing could see some light freezing rain. Precipitation amounts will be light, with only a light glaze of ice possible through Tuesday morning.
