

 afternoon.

Winter Storm Warnings:

- Eastern Norton Sound and Nulato Hills; Upper Kobuk Valleys; Lower Koyukuk Valley;
 Middle Yukon Valley; Lower Yukon and Innoko Valleys; Upper Kuskokwim Valley; Lower Yukon River warning remains in effect until 3PM AKST Thursday afternoon.
- South Slopes of The Central Brooks Range; Upper Koyukuk Valley; Dalton Highway Summits; Central Interior in effect until 3AM AKST Friday.

Winter Weather Advisory:

- Southern Denali Borough; Eastern Alaska Range South of Trims Camp advisory in effect until 3AM AKST Friday.
- Susitna Valley north of Talkeetna advisory in effect until 5PM AKST Friday.

Wind Advisory:
