

## Wrangell Landside Disaster:

The State and FEMA Joint Preliminary Damage Assessment group completed their out-brief yesterday.

# **Point Hope Power Outage:**

Water plant technicians have restored water and sewer to nineteen hones with another 60 still in need of service. Thawing is expected to be complete by next week.

#### Savoonga Power Outage:

Alaska Village Electric Cooperative technicians were able to restore power to community infrastructure, although 23 homes remain without power. The school and community lodge continue to shelter residents without heat with support from the Mass Care Task Force.

#### **Quinhagak Power Outage:**

Local operators continue to repair the power system, transformers, and utility lines within the Village of Quinhagak. SEOC has been fully engaged with a multiagency response to manage state declared disaster needs




#### **Avalanche Hazards:**



Avalanche danger for Cordova is considerable at altitudes above 2,000ft. Moderate at 1000-2000ft. Avalanche danger for Turnagain Pass ismoderate at all altitudes. Avalanche danger for Hatcher Pass is considerable at all altitudes. Avalanche danger for Valdez moderate at all levels and for specific terrain features that have been loaded by recent wind.
