# 2023 Spring Flood Event:

SEOC moved to Preparedness Level 2 – Heighten Awareness – today as the 2023 Spring Floods incident has stabilized with ongoing mass care and recovery work that does not require the dynamic operational coordination of a full multiagency Command and General staff engagement and ongoing incident planning process. Ongoing operational coordination for this incident will be handled at a tactical level. After today operational briefings for this incident will be on an as needed basis and an Incident specific SITREP will no longer be published unless conditions change. Significant 2023 Spring Flood incident updates will be provided in this standard SEOC daily statewide SITREP.

#### Significant Weather:



- Flood watch in effect for the Upper Koyukuk Valley until late Tuesday night.
- Flood warning in effect for Central Beaufort Sea Coast Flood waters are eroding the Dalton Highway between Milepost 401 and 407, with the road down to one lane. If conditions worsen, the road may wash out and become impassible. The Dalton Highway from mileposts 401 to 407. These conditions are expected to persist until ice in the main channel clears. Elevated flows are expected to continue, especially with rainfall expected late this week. Rain and snowmelt in the Brooks Range will cause the Sagavanirktok River to continue to slowly rise through Monday @ 2 PM AKDT. Travelers are urged to call 511 or visit 511.alaska.gov for the latest on road conditions in the area.
