Significant Issues:

City of Anderson – Waterwater Collection System

SEOC was contacted by the Denali Borough regarding ongoing heavy groundwater infiltration of the City of Anderson's wastewater collection system and continuous operation of their lift station pumps, with the attendant risk of pump failure. SEOC, the borough, and officials in the city participated in a conference call and are in communication with other pertinent agency representatives.

Kotzebue - Frozen Water Lines

SEOC has a staff member deployed to the community in support of the continued coordination of response and recovery.



Travel in avalanche terrain is not recommended. Avoid being on or beneath all steep slopes.


Hatcher Pass – Considerable at all elevations.
