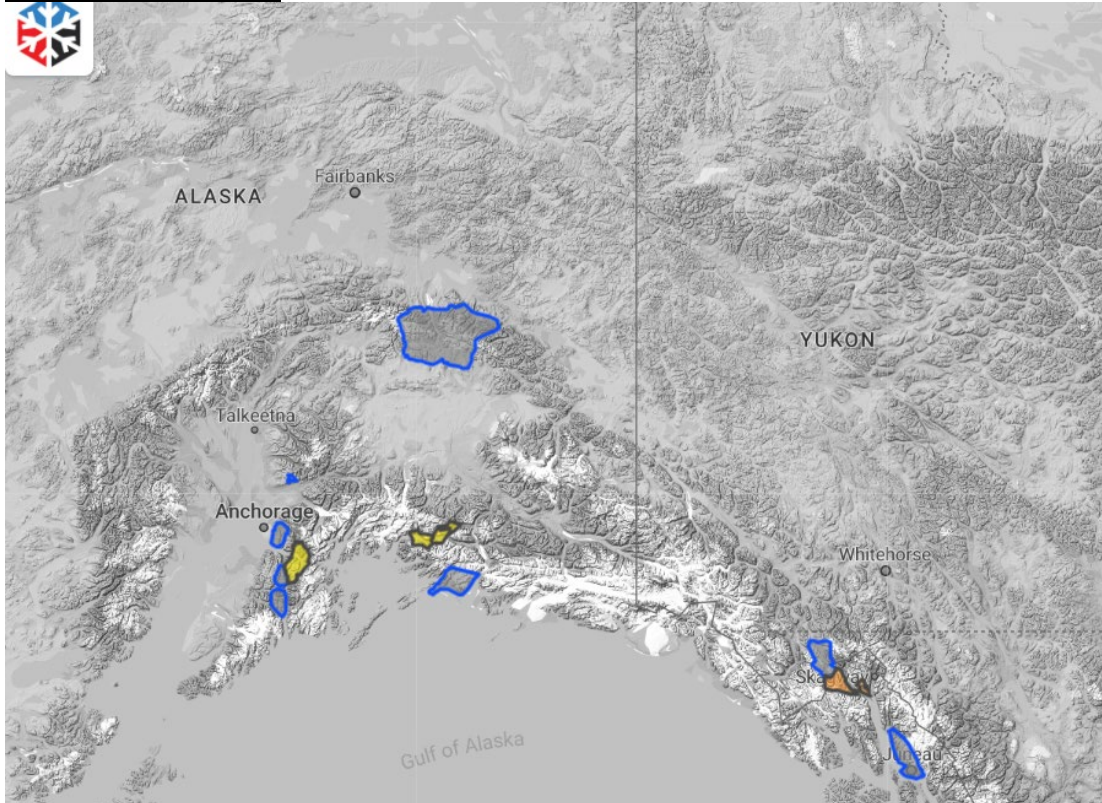

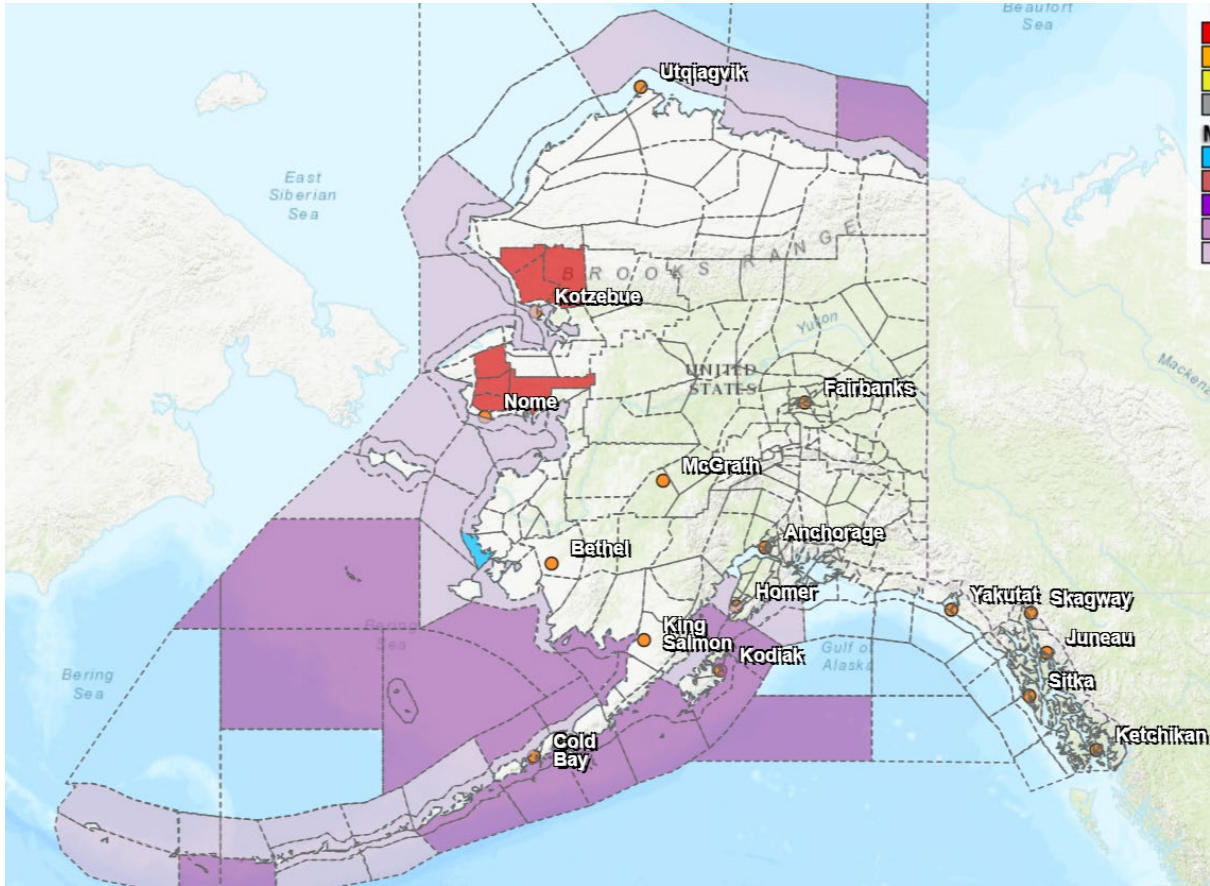
Avalanche Hazard
