Significant Issues:

Kivalina Structure Fire-

Following Tuesday's fire in two community buildings and a community-wide loss of power, 300 people were sheltered overnight Tuesday. An active response by the Northwest Arctic Borough, Alaska Village Electric Cooperative, Northwest Arctic Borough, and volunteer agencies resulted in community power restoration Wednesday and no one was sheltered last night.

The City of Kivalina and the Northwest Arctic Borough declared local disasters yesterday requesting state assistance and in response, Governor Dunleavy declared a State disaster for disaster Public Assistance and Individual Assistance.

SEOC is actively engaged with the Northwest Arctic Borough in response and recovery.


