## Significant Issues:

## Riverwatch

**Upper Yukon Division:** Over the weekend, Division flew to Circle, Chalkyitsik, and Eagle monitoring conditions. Division met with Chalkyitsik tribal council and supported emergency planning along with tribal and community members in Circle. Based on reports, community has moved equipment, vehicles, and supplies to higher ground. Division took Tribal Chief on local river reconnaissance flight to assess conditions and community is using Facebook Group "Fresh Eyes on Ice" to update community members.

Breakup front remains 29 miles upstream of Circle and the ice jam is estimated to be 10 miles long. Division will fly the Yukon River today, monitoring the breakup fronts and will report conditions and media interviews with Fort Yukon's KZPA Radio Station.

A Flood Watch remains in effect for Circle.

**Kuskokwim Division:** Over the weekend, the Upper Yukon Division conducted flights to Akiak and provided condition reports for Tuluksak, Kwethluk, Napaskiak, and Napakiak. Additionally, coordination was carried out with Kwethluk regarding a damaged water intake pump and SEOC continues to assist the local government.

Ice jams and primary breakup fronts:

- Mouth of Tuluksak River.
- Downstream of Mike Napitkas Island and Joe Boys Fish Camp.
- In front of Akiak airport.

Operations will continue to focus on monitoring conditions and providing updates to communities.

**Cooper River Division:** Yesterday, Division convened with area Incident Command to assess the flood impacts across the region. Flooding has affected several facilities, including the Glennallen Library, Legislative Information Office, Fire Station, and BLM facility, with water seeping into their basements.

Additionally, some residential area roadways experienced overtopping by floodwaters. Although road access is feasible, concerns persist regarding water inundation.

Klutina Lake Road Landslide: A landslide occurred on Klutina Lake Road over the weekend, rendering the road impassable for recreational users. Ground transportation facilitated the rescue of individuals, and no injuries were reported. Department of Transportation and Public Facilities (DOT/PF) road restore, and access will convene today with plans to address the situation.

State DOT/PF Operations: Flood Management on Glenn Highway

State DOT/PF has initiated significant pumping and flood-fighting operations along the Glenn Highway to safeguard critical infrastructure and ensure the safety of commuters. Division will maintain regular communication with area Incident Command and DOT/PF to facilitate a coordinated response and ensure timely updates on evolving conditions.

A Flood Advisory remains in effect for Glennallen.

A Flood Watch remains in effect the entire Copper River Basin.

### Middle Yukon Division:

Division plans to deploy Wednesday to Galena to conduct overflight of the middle portion of the Yukon River and meet with communities in that area.





Yukon Flats – Ice Jam flood watch for Circle tell Tuesday morning.

Kuskokwim Delta – Flood Watch until 11am Tuesday for Aniak.

Kuskokwim Delta – Flood Advisory for an Ice Jam in effect for Tuluksak until 645 Monday.

**Winter Weather Advisory:** Shishmaref; Bering Strait Coast, Western Arctic Coast, Central Brooks Range, and the South Slopes Of The Central Brooks Range – Winter Weather advisory in effect until 10pm this evening.
