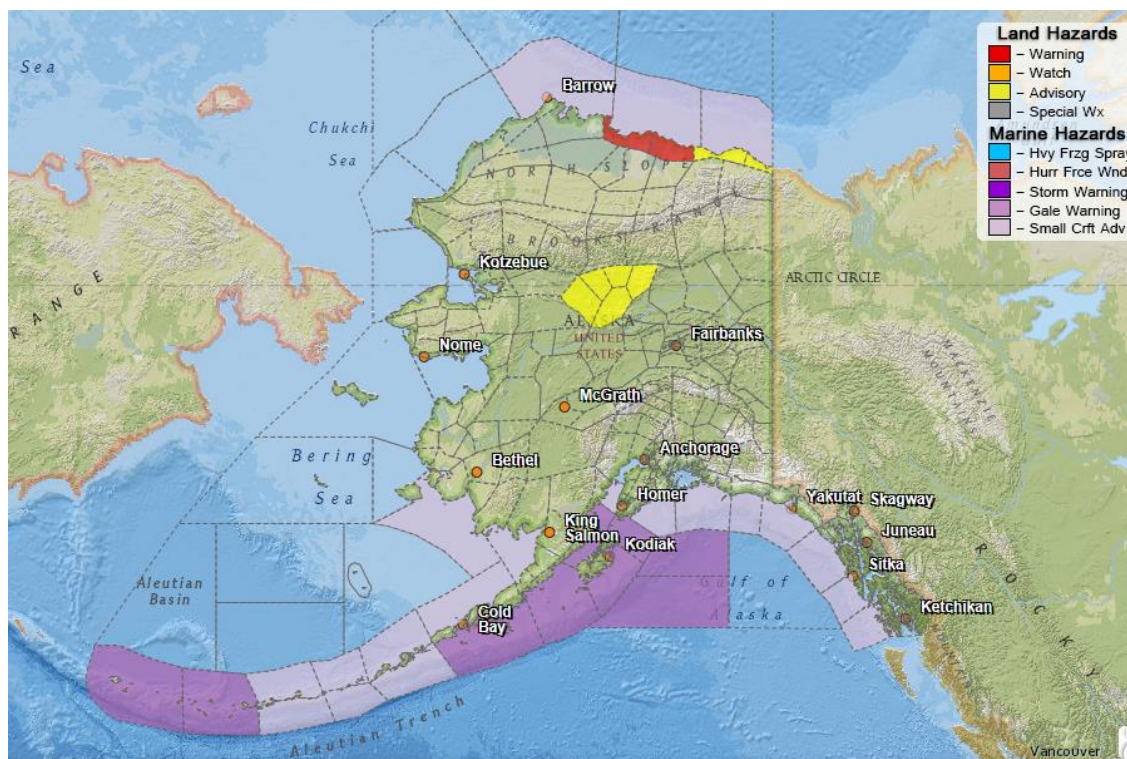

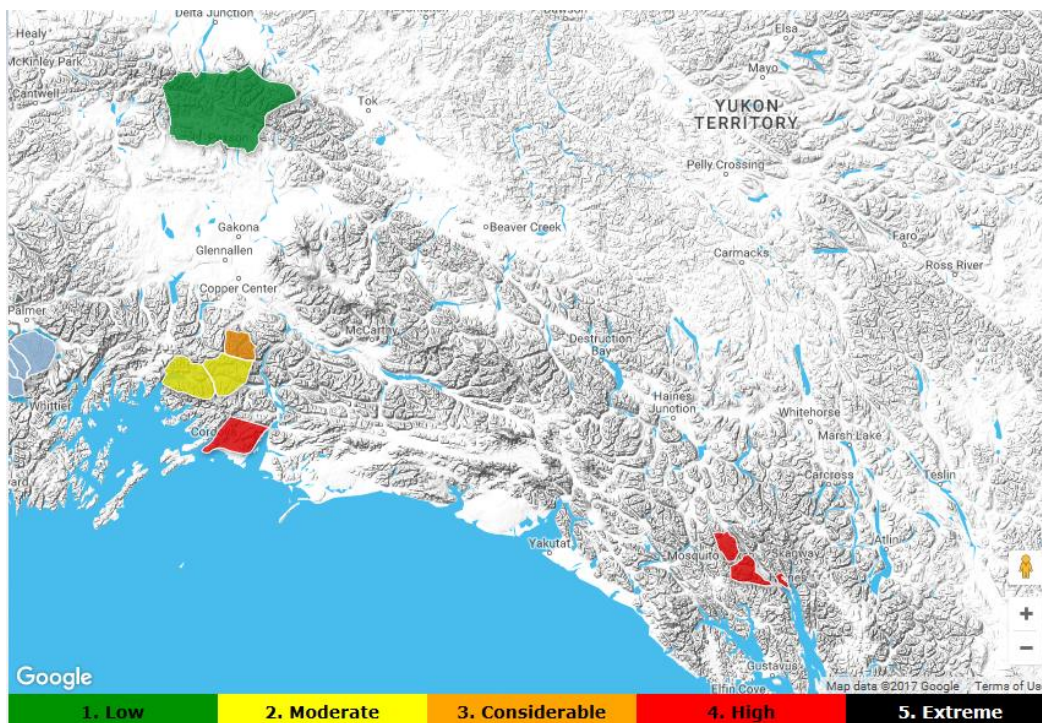
Significant Weather
