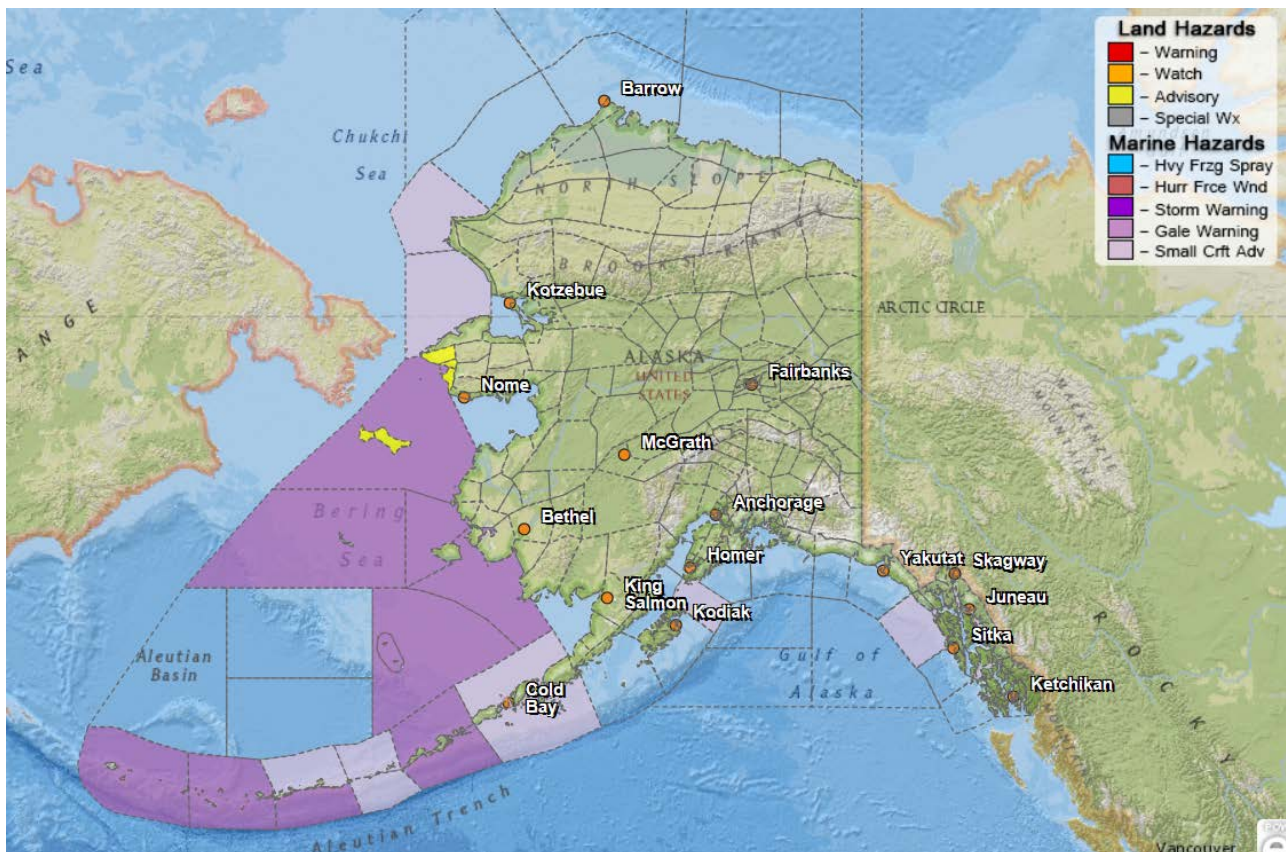

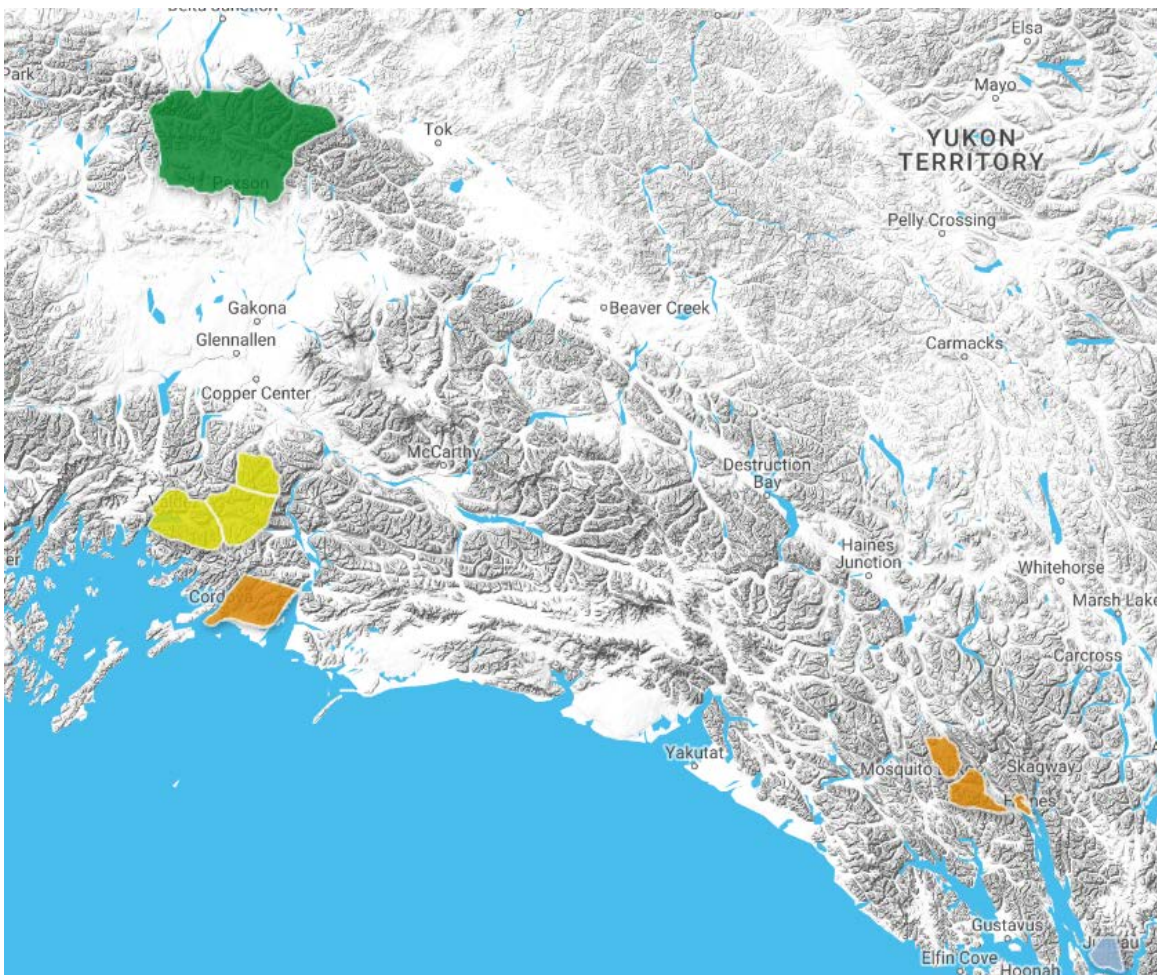
#### Significant Weather
