Revised APIP Charter

One of the primary tasks for the APIP this season will be the revision and adoption of a new three-year Charter. The methodology for the developing the new Charter will be discussed during the first few meetings of the season. If need be, a Charter Working Group will be formed to draft the Charter offline from the scheduled monthly meetings. The progress on the Charter will be briefed back to the full APIP group meetings prior to final adoption before the end of the season.

FEMA Region X Alaska Response Annex Revisions

FEMA Region X has begun work on revising their Response Annex for a catastrophic disaster in Alaska. The revisions will be conducted over the space of 6-8 months, and will require some input from APIP member organizations who provide essential services or maintain critical infrastructure. The working groups meetings will take place outside of normal APIP meetings, but discussions and invitations to participate in the revision process will be routed through the APIP distribution network.
