2023 Building Resilient Infrastructure and Communities (BRIC) Announcement

The State of Alaska DHS&EM is excited to announce the 2023 BRIC Grant Cycle. This communication is to inform eligible stakeholders interested in submitting for community Hazard Mitigation Plan (HMP) updates and mitigation projects. The formal Notice Of Funding Opportunity (NOFO) will be issued by FEMA in the late summer but entity leadership and community members should begin assessing their respective roads, public buildings, and other critical infrastructure where mitigation actions are intended to occur. This will allow more time to plan and develop project applications.

A community or tribe will be referred to as a <u>Sub applicant</u> once an *Intent to apply (ITA)* – Community HMP updates or a *Notice of Interest (NOI)* – Projects and studies have been submitted to the State, the State will be referred to as the Applicant.

The sooner a community/borough has worked up a plan on what mitigation actions they intend to carry out in this grant cycle they should contact our office to secure placeholders, this will give us time to work together with the appropriate point of contact for every project, HMP update, etc.

Thank you for your continued interest in the BRIC program. We welcome all questions and concerns that come through the mitigation office, our contact information is provided below. Below is some need-to-know information for the public. Solid dates and updates will be determined once the Federal Emergency Management Administration (FEMA) Notice Of Funding Opportunity (NOFO) for BRIC '23 has been released.
