Yup'ik Language Tool Supports Behavioral Health Understanding

Moses Marr'aq Wiseman, a Yup'ik speaker from Chefnak, recently supported evacuees from Western Alaska by providing Yup'ik interpretation at Anchorage shelters, using a newly developed glossary of behavioral health terms. Having culturally appropriate language available, he said, helped ease conversations and made it easier for people to understand and talk about their experiences.

Wiseman, who serves as Alaska Native Languages Program Director at the Alaska Institute for Justice, helped launch the free, online Yup'ik behavioral health glossary last month. The resource allows users to search health-related terms, see Yup'ik translations, and hear correct pronunciation.

Funded by a grant from the Alaska Department of Health, the glossary was developed over several years through collaboration with Yup'ik speakers, interpreters, and medical professionals. Project leaders emphasized that the glossary is a "living" resource that will continue to evolve as language and community needs change.

January is Mental Wellness Month - Behavioral and Mental Health Services Available

The Alaska Native Tribal Health Consortium (ANTHC) offers behavioral health services to all Alaska Native and American Indian adults age 18 and older who are physically present in Alaska.

Through the ANTHC Behavioral Health Wellness Clinic, individuals can access behavioral health assessments, health behavior coaching, individual and group counseling, and referrals to additional resources or treatments. All services are available via telehealth, allowing patients to receive care from home.

The Behavioral Health Wellness Clinic is designed to support overall wellness but is not a crisis service. If you are experiencing a medical emergency, call 911. If you or someone you know is in a mental health crisis, call or text the Suicide & Crisis Lifeline at 988 for immediate support.

Disaster Unemployment Assistance Deadline Extended to February 20

If you were impacted by Typhoon Halong and are unable to work due to storm-related damage, Disaster Unemployment Assistance (DUA) is still available. The application deadline has been extended to **February 20, 2026.**

DUA provides temporary financial help for people who are not eligible for regular unemployment or have exhausted benefits. Weekly assistance ranges from \$153 to \$370 and may be available for up to 27 weeks.

To apply, call **(907) 465-4691** and ask for Disaster Unemployment Assistance. Interpreter services are available at no cost.

Don't Miss Out on Help - Deadlines Extended for Financial Assistance

The deadline to apply for individual assistance programs from the State of Alaska and FEMA, in addition to SBA disaster loans has been extended to February 20, 2026.

Applying to multiple assistance programs increases your chances of receiving the full support your family needs, whether that's help with temporary housing, home repairs, personal property, transportation, or other essential needs.

Each program provides different types of support, and no single program covers every kind of loss—this is why it's important to apply for more than one.

And remember: you can apply online or over the phone.

If you're unsure where to begin, shelter staff and on-site partners can help guide you through the process.

The sooner you apply, the sooner assistance can begin.
