Significant Issues:

Juneau Suicide Basin Flooding

The City and Borough of Juneau along with the SEOC is coordinating multi-agency response and recovery efforts in Juneau. Governor Dunleavy declared a State disaster for Individual (AI), Public (PA), and Temporary Housing assistance yesterday and the SEOC is deploying a Branch Director to assist with mass care, volunteer coordination, and operations support, as CBJ is transitioning their EOC operations from response to recovery. SEOC Mass Care is in coordination support with CBJ, Red Cross, Salvation Army, and other faith-based/volunteer agencies providing clean-up kits, emergency meals, emergency clothing vouchers, donation coordination, and availability of volunteer manpower to "muck-out" homes. Red Cross began extensive residential damage assessment today, and SEOC Recovery Branch IA Group is coordinating with Red Cross to receive their information and apply that to expedite State IA. SEOC Recovery Group is in the process of opening Disaster IA programs for this incident and connecting with CBJ to provide PA technical assistance.

Statewide Wildland Fire Situation and State SEOC Fire Support:

With a change in weather, wildland fire activity is beginning decreasing. Despite Red Flag Warnings in effect through this evening, multiple days of wetting rain adding up to more than one inch will be needed for lasting relief. Both Fairbanks area and Anderson area fires reduced their evacuation levels in some areas today from "GO" to a lower levels. SEOC continues to have the MEOC deployed with an SEOC Operations Specialist on the Anderson Complex Fire. Alaska National Guard Armory in Fairbanks continues to support fire crew mobilization. UH-60(s) continue to provide suppression support when able to fly due to weather and fire/smoke conditions. Firefighters from the 176th Air Guard continue to work on active suppression. SEOC is continuing to monitor fires and is prepared to assist with any needs.

Air Quality Index (AQI) Advisories

Air Quality Advisory still in effect for Central and Eastern Alaska and for South Central Alaska; and Southeast Alaska until 2 PM AKDT on Wednesday August 9, 2023. Severe smoke impacts within the Tanana Flats/Valley. With wind air quality will vary between GOOD and HAZARDOUS.

Air Quality Advisory issued for the North Slope as smoke from Canadian fires have migrated into the eastern portion of the North Slope combined with Upper-level smoke settling to the surface from the Interior fires. Advisory is valid until Wednesday August 9, 2023, at 2:00PM.


