Significant Issues:

SEOC Preparedness Level:

Dropped from Level 2 to Level 1 (Routine Operations) due to recent cool, wet weather that has reduced wildland suppression efforts.

Clark’s Point Water System:

SEOC will have a community conference call with DEC, DCRA-LGS, BBAHC and Mass Care groups today to support the community’s water needs and repairs. Water boil notice in effect from 6/27 until further notice.

Alaska Wildland 2024 Fire Season Statewide Overall:

No Red Flag Warnings today. The Alaska Interagency Coordination Center Preparedness Level dropped from Level 4 to Level 3 due to recent cool, wet weather.

Alaska Wildland 2024 Fire Season Evacuation Status:

Globe Fire #253 (Grapefruit Complex):

- Go- **Red:** There are no areas currently in RED status.
- Set- **Yellow:** There are no areas currently in YELLOW status.
- Ready- **Green:** for residences from MP 18-65

*Staffed-due to rain, downsizing organization over next week.

*DOT temporarily repaired the road at MP57 and are utilizing one lane and pilot cars to facilitate traffic flow.

Riley Creek Fire #318 (Denali):

- Go- **Red:** There are no areas currently in RED status.
- Set- **Yellow:** There are no areas currently in YELLOW status.
- Ready- **Green:** There are no areas in the Denali Borough, outside of the Denali National

Park and Preserve boundary, in GREEN status. As of Saturday, July 6, the Denali National Park and Preserve campus housing area is being lowered to Green-Ready status. Anyone in GREEN areas should stay alert and monitor for evacuation status updates.

*Staffed-minimal fire behavior today.

Montana Creek Fire #312 (Mat-Su Valley):

- Go- **Red**: There are no areas currently in RED status.
- Set- **Yellow**: There are no areas currently in YELLOW status.
- Ready- **Green**: There are no areas currently in GREEN status.

*Staffed- Personnel continue efforts on breaking down resources and setting up backhaul for unused supplies.

McDonald Fire #119 (Fairbanks North Star Borough):

- Go- **Red**: There are no areas currently in RED status.
- Set- **Yellow**: There are no areas currently in YELLOW status.
- Ready- **Green**: There are no areas currently in GREEN status.

*Staffed-Idaho Team 1 assumed command of fire today.

The Alaska Interagency Coordination Center is now at Preparedness Level 3

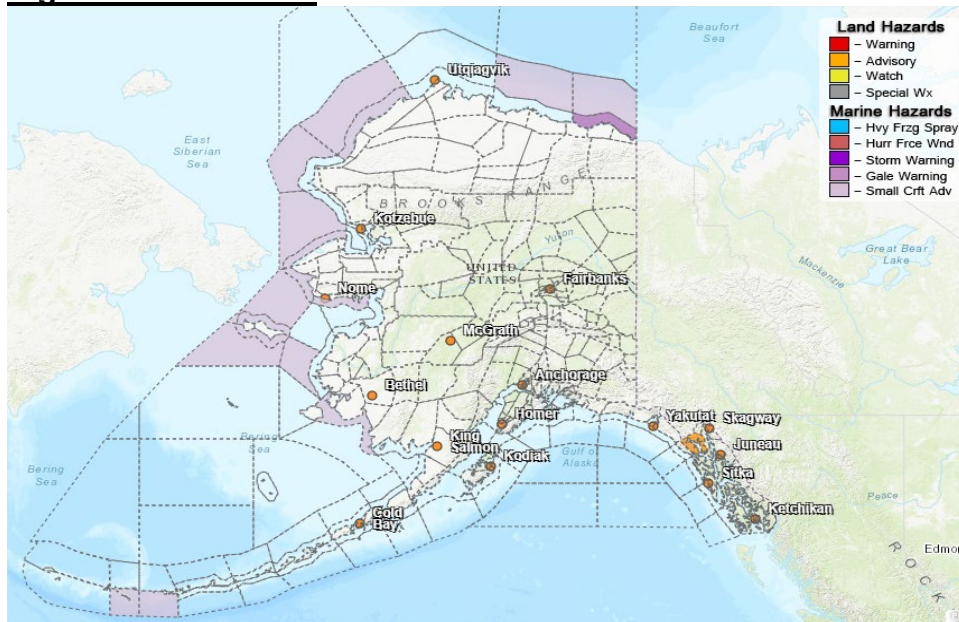
