The Alaska Interagency Coordination Center is now at Preparedness Level 3

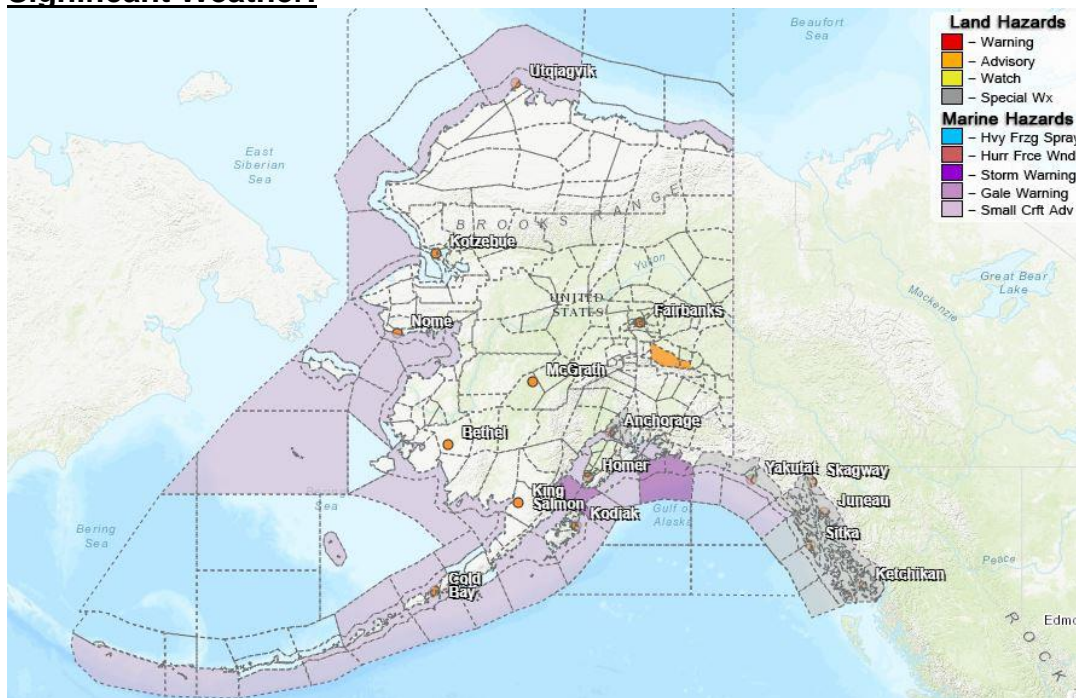

- **East Turnagain Arm** – Strong southeasterly winds early Friday afternoon through Saturday evening.
