# **Significant Issues:**

SEOC contacted the community of Hyder regarding high water on the Salmon River due to the glacial dammed lake release. National Weather Service Juneau states that water levels will continue to rise through the next few days as water drains from Summit Lake. Water is expected to recede starting late this week. Potential minor flooding impacts near mile 9 along the river road. SEOC will continue to provide assistance as needed.
