Significant Issues:

2024 Aug Juneau Glacier Flood Incident:

The Mendenhall Glacier's Suicide Basin released water, causing a flood in the Mendenhall River and Valley. The flood crested at 1:00 AM, surpassing the 2023 record by one foot. Water levels are now receding. An evacuation warning was issued before the flood. There were no injuries, but water rescues and evacuations occurred. Power remains off in the flooded area pending a safety assessment

The Red Cross sheltered 45 residents Monday night at a local middle school, providing breakfast. All sheltered residents have now found alternate accommodations. Four patients from an assisted living home were evacuated and relocated.

Initial reports indicate approximately 100 homes, and some businesses were inundated. Roads and infrastructure suffered erosional damage. ADEC's aerial survey observed minor spills and a full ground-based survey is pending.

Governor Dunleavy declared a disaster emergency, activating state assistance programs. The SEOC has deployed personnel to coordinate the state response and support CBJ's Incident Command. SEOC is at Preparedness Level 3, engaging multiple agencies and coordinating with FEMA.

State of Alaska Department of Health (DOH):

The DOH is ready to assist with all aspects of public health and is supported by the SEOC and other state departments as required in the event of a public health emergency.

Alaska Wildland 2024 Fire Season:


The Alaska Interagency Coordination Center is now at Preparedness Level 1
