**Significant Issues:**

**West Coast Storm**

This past weekend, storms affected the west coast of Alaska, leading to flooding in coastal and Kuskokwim communities. Reports include loss of personal property (boats, snow machines), damaged boardwalks, overturned/lost fuel tanks, and bank erosion. No significant residential or infrastructure impacts have been reported.

The remnant of Typhoon Ampil is expected to impact the West Coast from tonight through Thursday. The latest forecast predicts moderate impacts, including minor coastal flooding, wind damage to unsecured objects, and localized flooding.

The SEOC is in contact with affected communities, all of which report being prepared. SEOC has coordinated with ADEC, AST, AKOM, and other partners on contingency plans. An AKOM UH-60 helicopter conducted an aerial survey yesterday; results are pending. SEOC continues to monitor the situation and maintain communication with communities.

The Alaska Interagency Coordination Center is now at Preparedness Level **1**

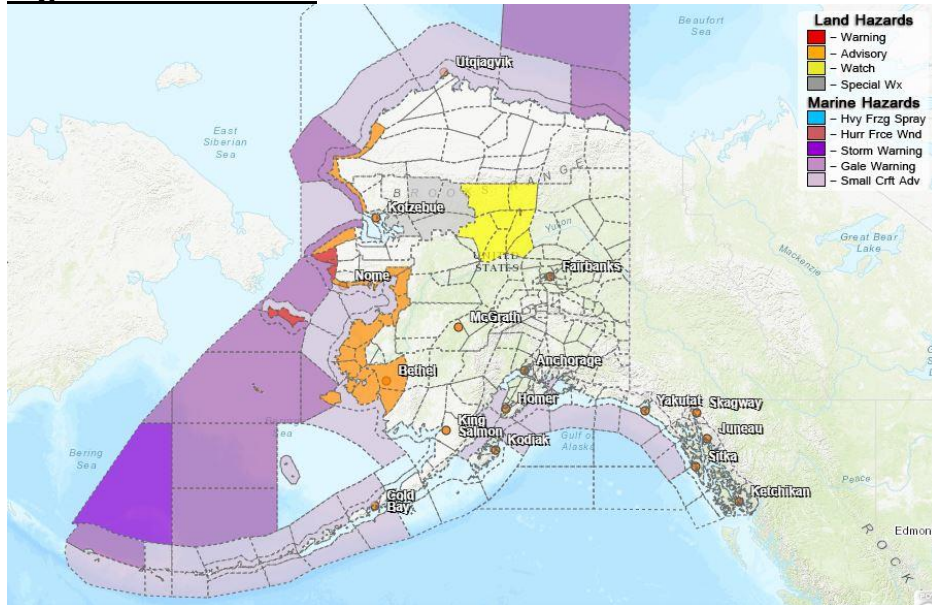
