# **Significant Issues:**

#### **West Coast Storm**

Another, stronger storm, the remnant of Typhoon Ampil, is impacting Alaska's West Coast today through Thursday.

SEOC is in contact with the communities in the forecast storm track as well as ADEC, AST, Calista Corporation, ANTHC, YKHC, TCC on preparedness and impacts. AKOM has surveyed forces to be ready-to respond if needed. No AKOM requests at this time.

SEOC coordinated a briefing with NWS and TCC Emergency Management as the communities of Allakaket and Hughes raised concerns with TCC about road flooding isolating elders and airport access with the potential for relocating elders outside the community as a precaution.

SEOC has staff available overnight and tomorrow to respond to community reports and requests for assistance. As of this report, no substantial residential or infrastructure impacts are reported.


