Significant Issues:

Juneau Glacier Flood:

- State and Federal and Tribal PDA completed.
- State IA Registrations: 224
- Joint Preliminary Damage Assessment with FEMA, SBA, CBJ, Tlingit & Haida and State staff concluded field assessments. An out-brief is scheduled for Tuesday morning to report the agreed-upon costs for damages to public infrastructure and individual homes.

The Alaska Interagency Coordination Center is now at Preparedness Level **1**

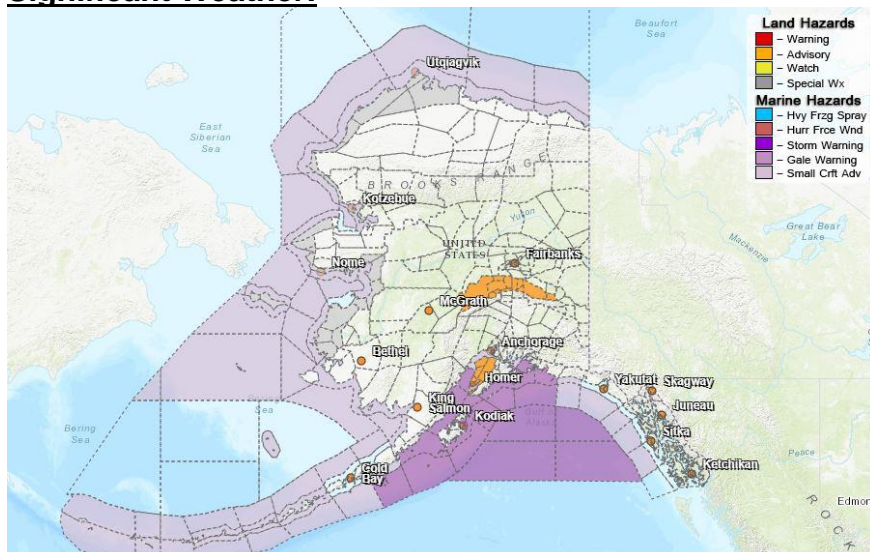
