The Alaska Interagency Coordination Center is now at Preparedness Level **1**

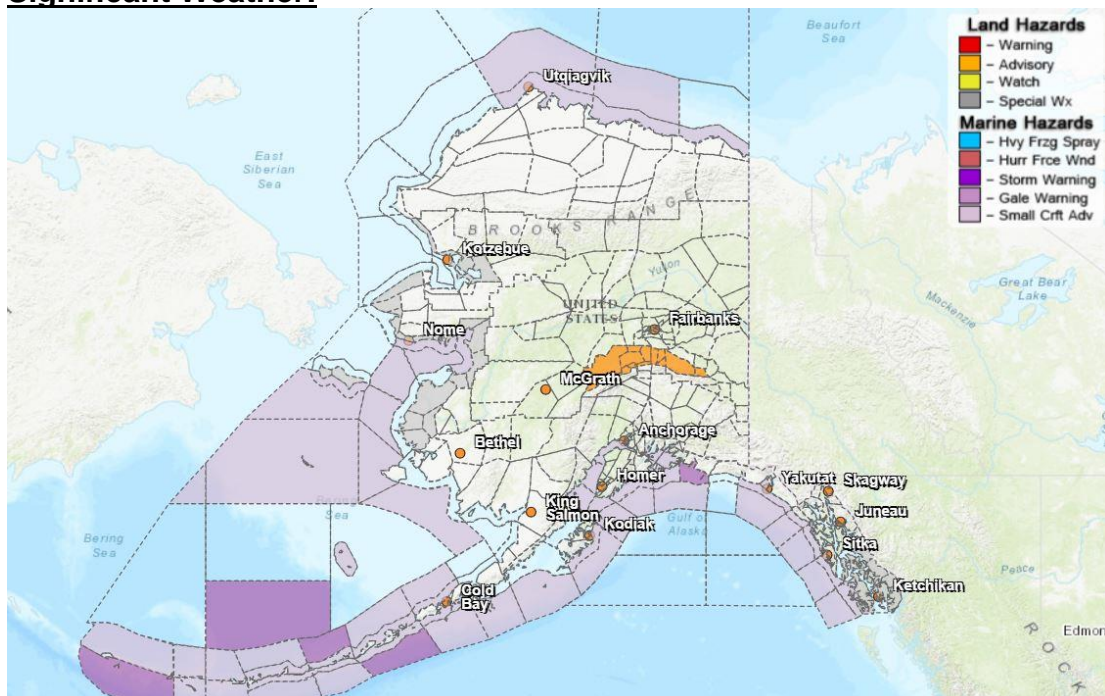
