Noatak/Northwest Arctic Borough:

Late yesterday, SEOC received a signed declaration from the Northwest Arctic Borough, in response to the local declaration from the Village of Noatak. The Village of Noatak signed a local declaration requesting assistance from the Borough on Aug 6th due to flooding and bank erosion. SEOC will contact local and state organizations to coordinate assistance.

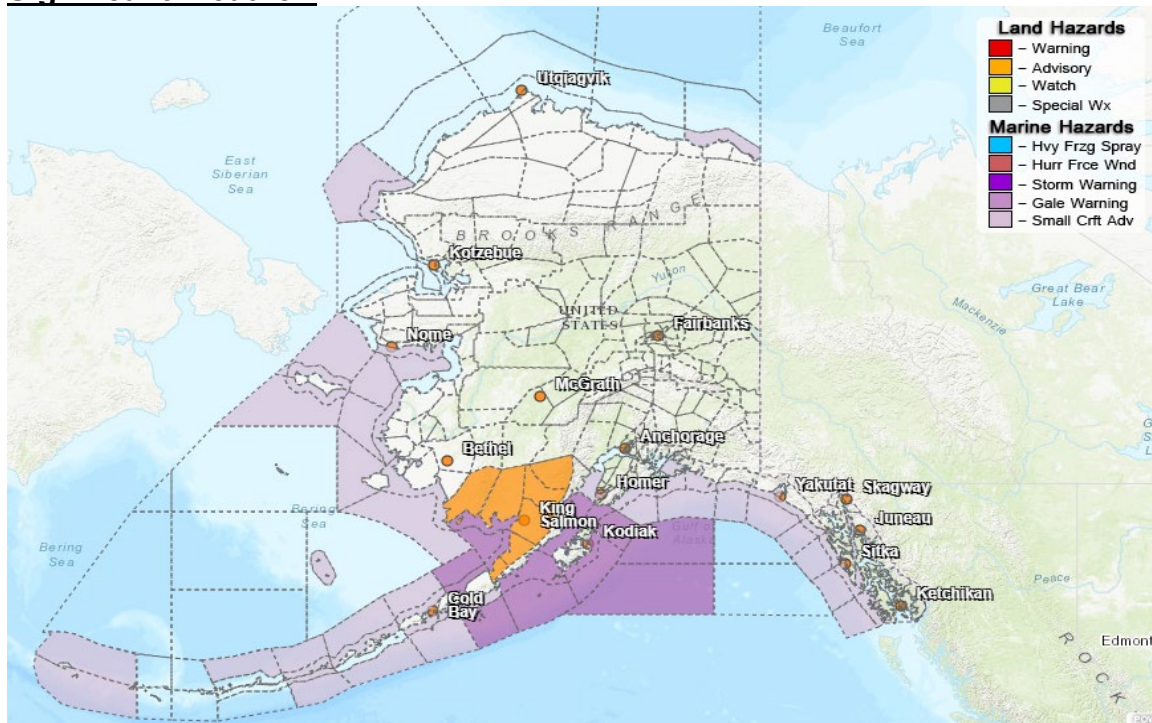
