Significant Issues:

National Hurricane Support:

Over the weekend, SEOC participated in a national Hurricane support call and deployed additional personnel in response to Hurricane activity under the nationwide Emergency Management Assistance Compact (EMAC). SEOC continues to receive and evaluate mission requests from states affected by hurricanes. A nationwide coordination call took place today, and SEOC will continue to engage throughout the week in support of states impacted by Hurricane Helene or preparing for Hurricane Milton.

Currently, SEOC has deployed a Volunteer Agency Liaison to Florida, a Volunteer Agency Liaison to Virginia, and two SEOC Operations and Logistics personnel to North Carolina under EMAC. Offers of additional assistance to requesting states are under consideration, including a SEOC EOC Support Team to North Carolina (four personnel) and an Alaska National Guard general-purpose company (16 personnel on state active duty). SEOC will continue to offer additional National Guard, Emergency Management, and other state agency personnel as mission requests are received, provided that Alaska's personnel or equipment can meet the needs of the mission.

Ketchikan New Slide:

On Sunday evening, a small landslide occurred in the Borough area of Ketchikan. The Department of Transportation and Public Facilities (DOT/PF) and the Alaska State Troopers (AST) responded to the event. There were no injuries or damage to residential property, although some residents were temporarily cut off from vehicle access. Ketchikan officials, along with AST and DOT/PF, were able to assist the residents, and SEOC confirmed with Ketchikan that no state assistance is required at this time.

Ketchikan Landslide Disaster Preliminary Damage Assessment (PDA):

SEOC began conducting a Preliminary Damage Assessment (PDA) with FEMA today for the August 2024 Ketchikan landslide disaster. This assessment is necessary to pursue Federal assistance for recovery efforts.
