Significant Issues:

SEOC Preparedness Level:

SEOC moved to Preparedness Level 2 – Heightened Awareness Saturday (Oct 19) to actively monitor and coordinate response as needed for the forecast West Coast Storm and Juneau Flood Warning.

Juneau Glacier Outburst Flood Warning:

Saturday (Oct 19) morning, National Weather Service (NWS) advised SEOC that the Suicide Glacial Basin above the Mendenhall River had released and that they had issued a Flood Warning for the Mendenhall Valley of Juneau. While the amount of water released and forecasted impacts were not as serious as this August's disastrous flood, the water levels could possibly flood residences along View Drive and inundate the campground area again. Flood water was forecast to peak around 0100 hrs. on Monday (Oct 21).

SEOC established contact with CBJ, Tlingit and Hadia Tribes, FEMA, and NWS for updates and coordination.

As of this morning (Oct 21), Juneau Emergency Management reported that the flood water levels were not high enough to cause significant damage and water was receding rapidly. NWS canceled the Flood Warning at 0413 this morning.

Strong West Coast Storm:

A strong winter storm was forecast for Alaska's west coast starting this weekend (Oct 19-20). Friday afternoon (Oct 19), NWS advised SEOC that the forecasted storm surge with the storm, given coincident high tide, could inundate low lying areas of communities from North Sound-north. The storm was also going to generate significant snowfall for the Alaska's Interior into Fairbanks.

SEOC recalled staff on Saturday (Oct 19) to contact communities at storm surge risk and did coordination calls with regional tribal partners, state agencies, and communities to confirm awareness and support preparedness actions.

SEOC continues to monitor this storm and its impacts as it moves across Alaska.



• Kuskokwim Delta-minor flooding is possible along lower Kuskokwim River through Thursday.

Winter Storm Warning:

 Central Brooks Range, Southern Denali Borough, South Slopes of the Central Brooks Range, Upper Koyukuk Valley, Dalton Highway Summits, White Mountains and High Terrain South of the Yukon River, Upper Chena River Valley, Chatanika River Valley, Eielson AFB and Salcha, Goldstream Valley and Nenana Hills, Two Rivers, Fairbanks Metro Area, Nenana, Upper Kobuk Valleys, Noatak Valley, South Slopes of the Western Brooks Range-in effect until 4pm Tuesday.
