Significant Issues:

West Coast Storm:

SEOC has successfully transitioned to recovery in Kotzebue, Northwest Arctic Borough (NWAB) and the Bering Strait Regional Attendance Area impacted by the 2024 October West Coast Storm disaster and returned to the Routine Operations - Level 1 Preparedness Level.

- State Disaster Individual Assistance registration is open.
- SEOC deployed a Volunteer Agency Liaison (VAL) who is mutual aid from Colorado under the Emergency Management Assistance Compact, to Kotzebue, to support long-term recovery efforts. **The Val demobilized on Saturday.**

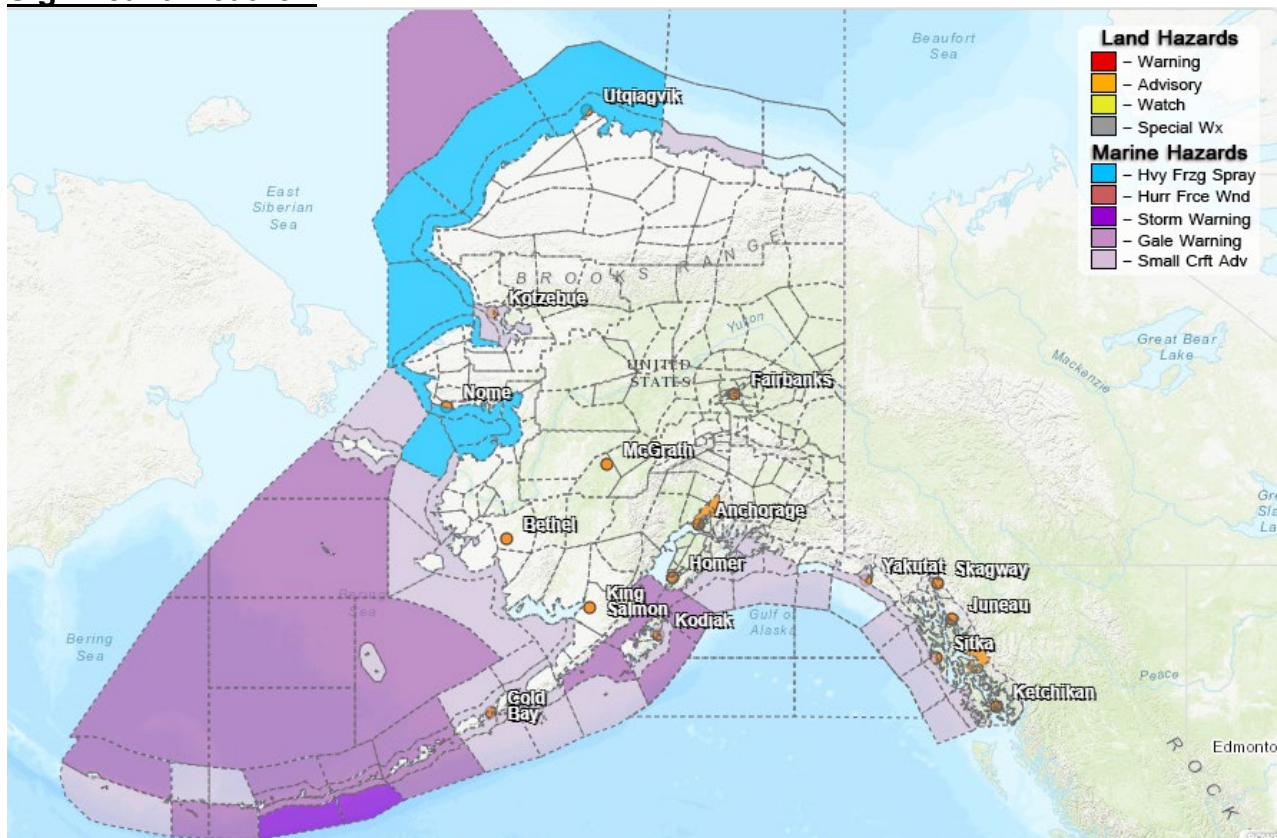
