Significant Issues:

Homer Spit Storm:

On November 16-17, 2024, a storm with strong winds caused wave damage to the Homer Spit and in Ninilchik. Late Monday, the City of Homer declared a local disaster in response to the storm. SEOC Division Supervisor has been deployed to Homer to work with the Kenai Peninsula Borough, City of Homer, Alaska Department of Transportation and Public Facilities to gather storm damage impacts.


