# Significant Issues:

### Homer Spit Storm:

The Sterling Highway (Homer Spit) was open to full service on Wednesday night, November 20, 2024. This concludes the immediate emergency response for road repairs. City of Homer is regulating speed at 15 mph on the roadway as a precaution. SEOC deployed an Operations Specialist this week who met with the Kenai Peninsula Borough, City of Homer, and Alaska Department of Transportation and Public Facilities to assess damages and

coordinate the state response.



#### High Wind Warning:

- **City and Borough of Juneau**-in effect from 3pm this afternoon until 3pm Saturday. **Hydraulic Outlook** 
  - Anchorage, Matanuska Valley, Western Kenai Peninsula, Susitna Valley-rapid freeze up of local rivers and streams ongoing.
