# Significant Issues:

#### **Point Lay:**

The community of Point Lay suffered a complete loss of power due to blizzard conditions over the weekend. The SEOC Duty Officer was in contact with the Inupiat Community of the Arctic Slope (ICAS) over the weekend, and there are no current needs from the state at this time. They have been working closely with the community as well as the North Slope Borough throughout this incident. The community is in the process of assessing the damage and/or heating the loss of power may have caused. ICAS has been in contact with SEOC and FEMA Region 10, and a tribal declaration has been submitted to FEMA. SEOC will continue to stand by for support as necessary.

### City of Hooper Bay:

Community households can now collect 5-10 gallons of water from the plant/washeteria daily. According to the ADEC's Drinking Water Program, the water collected is still under a BWN until testing can be conducted.

### Kiana – Frozen Water Lines

EOC meetings continue. The community's priorities are thawing the west water loop and repairing the recently frozen sewer lines. SEOC remains available to offer aid.


