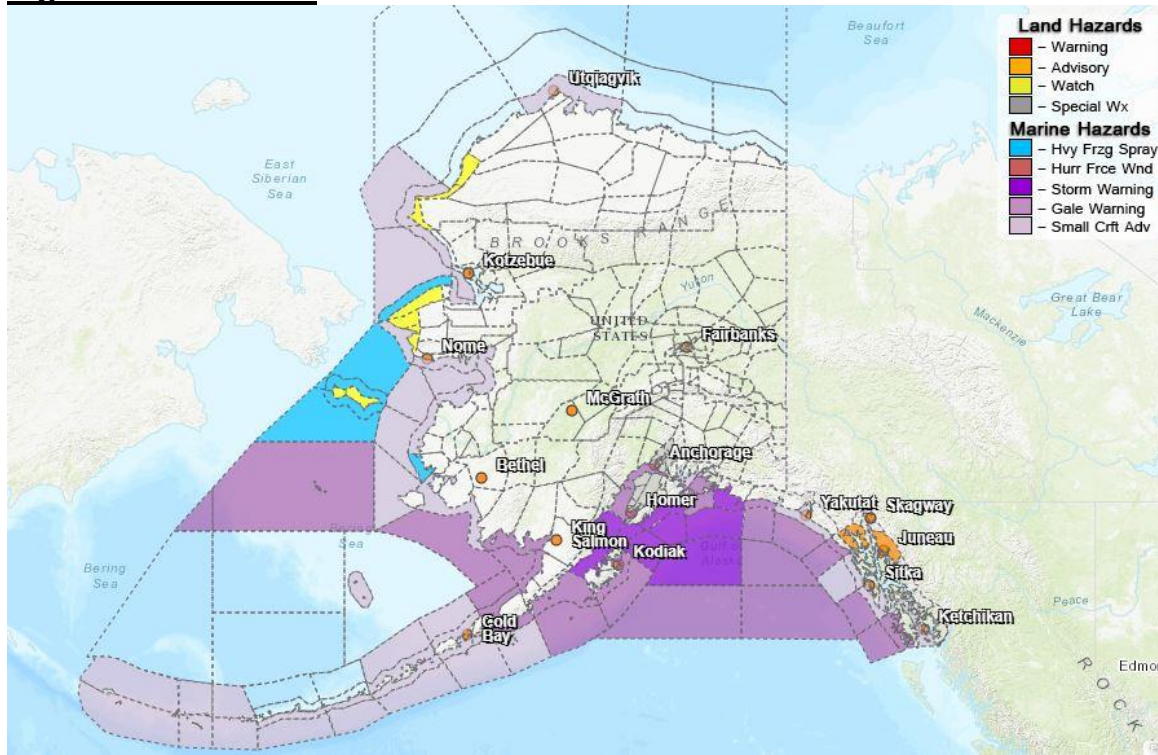

Anchorage; Matanuska Valley; Western Kenai Peninsula – Rain and Freezing rain this weekend.

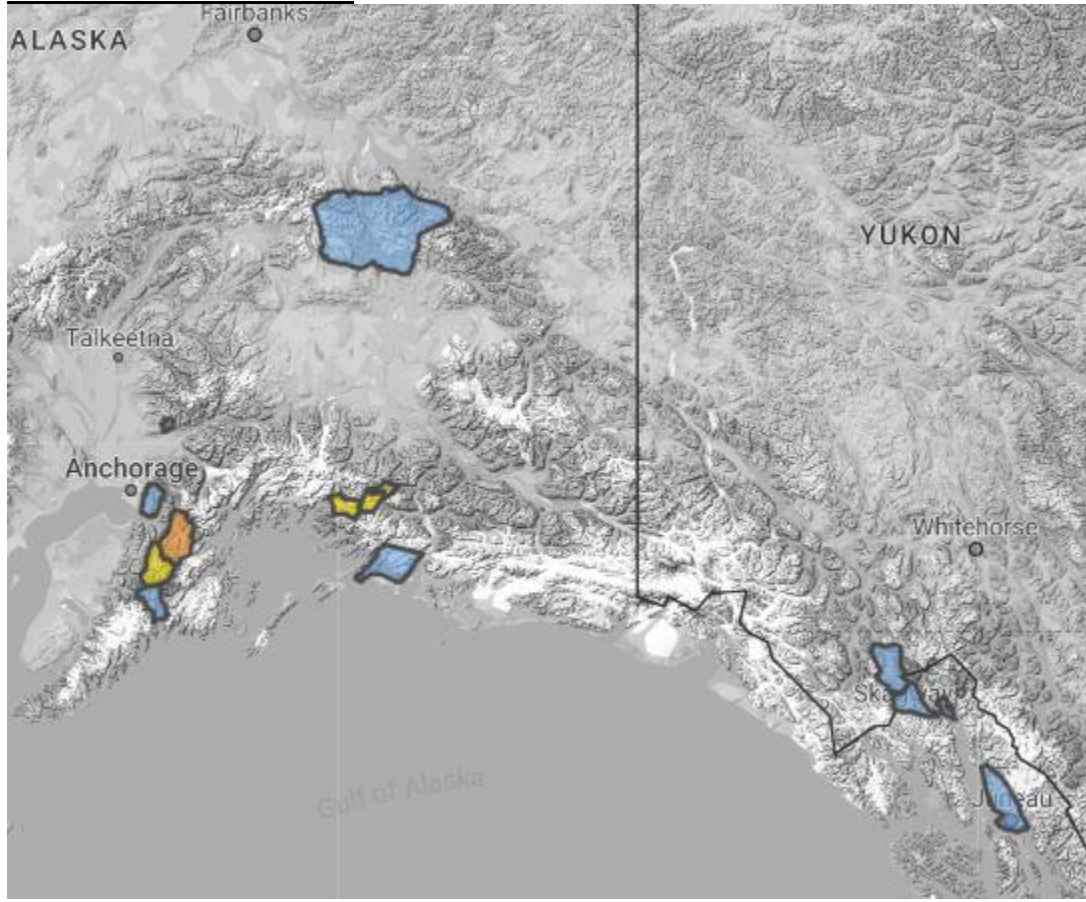
