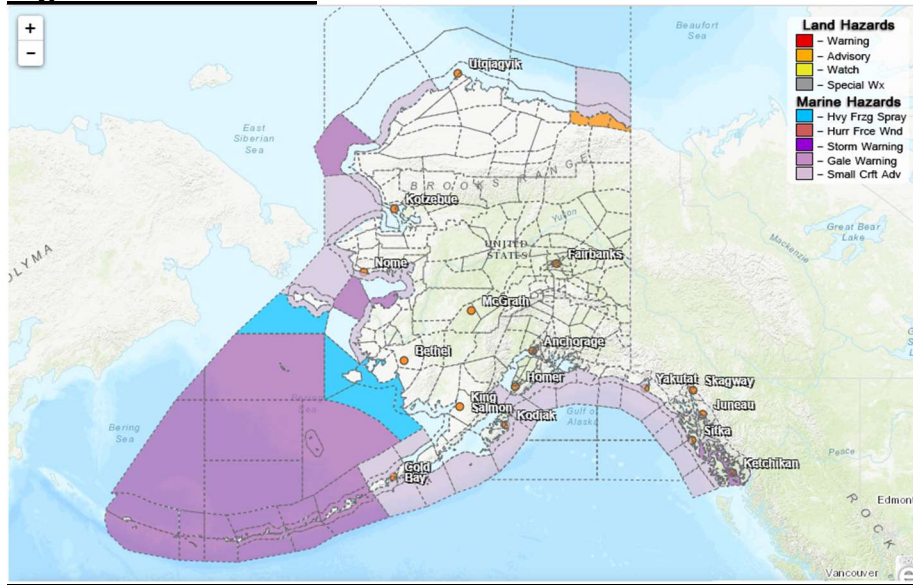

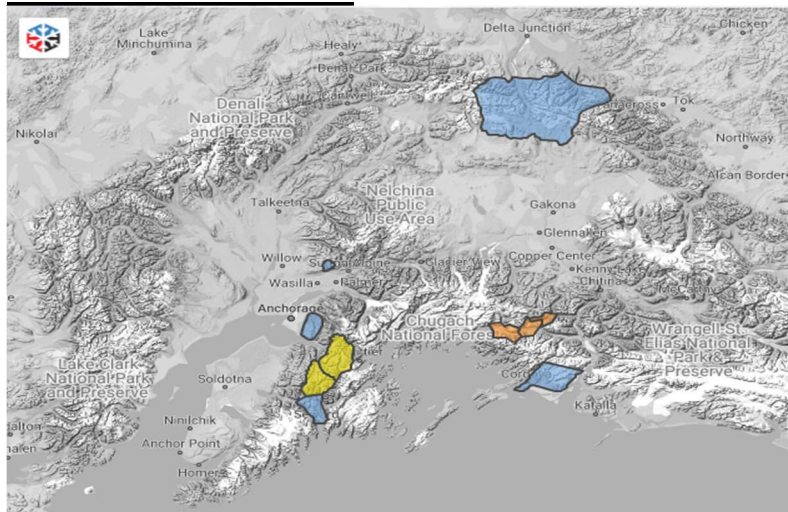
Winter Weather Advisory:

Summit Lake – Moderate above 2500', Low 1,000 -1,500'

Maritime – Moderate below 1,500', Considerable above

Intermountain - Moderate below 2,000', Considerable above

Valdez/Continental - Moderate below 2,000', Considerable above
