**Significant Issues:**

**Napakiak Erosion and Water Plant:**

SEOC contacted ADEC yesterday to follow-up on bank erosion near the community water plant and water source. With ADEC consultation, the community intends to move the building to save equipment and cap the current well. A new water plant and water source was completed in April and the community will begin using that when the current water plant is decommissioned.

**Kuskokwim River Spring Flooding:**

Governor Dunleavy has declared a disaster for the Kuskokwim River communities in the Lower Kuskokwim and Yupiit Regional Education Attendance Areas in response to flooding. To apply for Individual Assistance, see link and phone number below.

## Riverwatch Breakup:

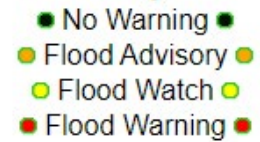

### River Status

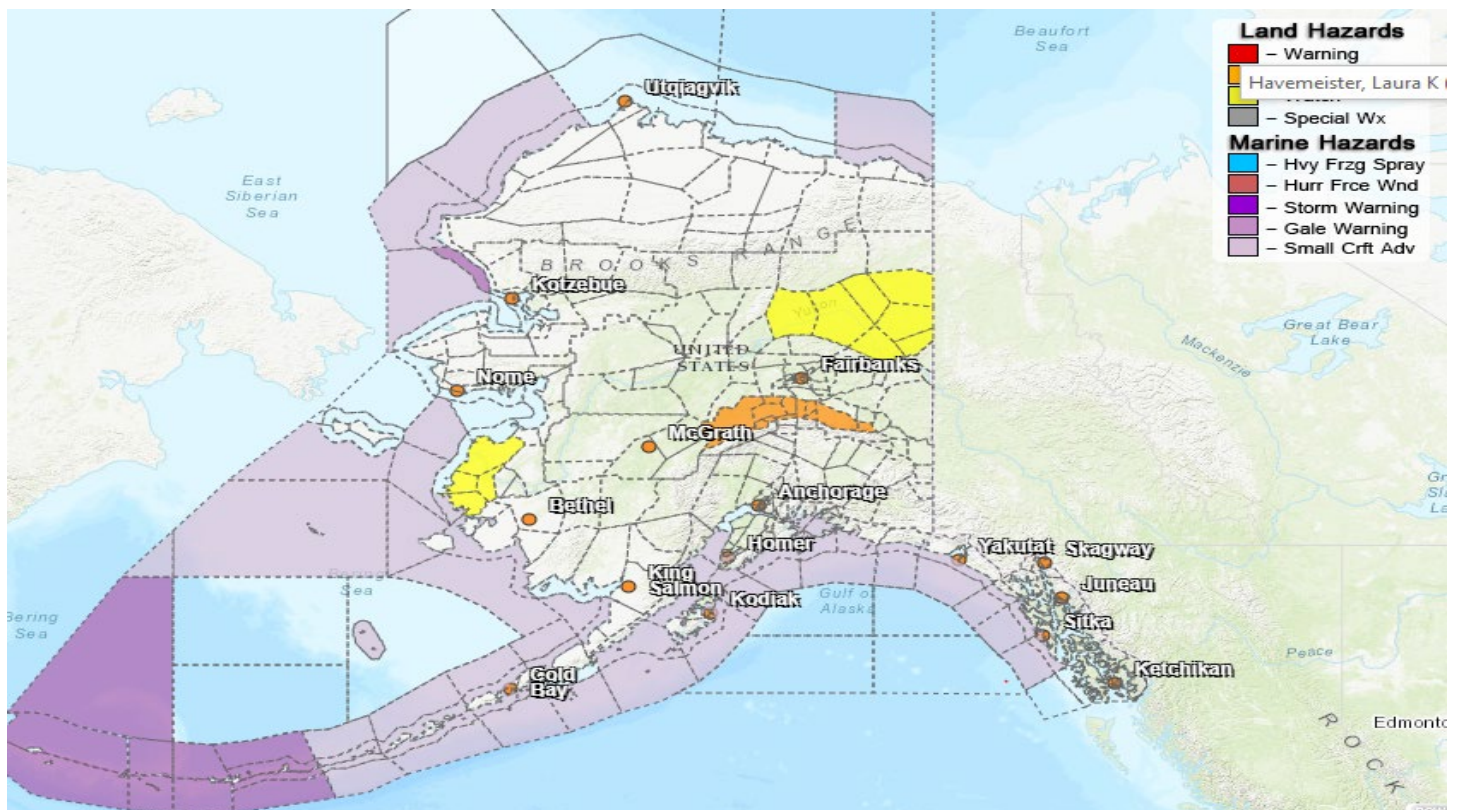
