Significant Issues:

Riverwatch

Lower Yukon Division:

Flood Warning remains in effect for the Lower Yukon Delta Coast at Emmonak, Alakanuk, and Nunam Iqua through Friday afternoon.

Emmonak:

SEOC is actively engaged with the community and AST Trooper in the community who is providing regular reports. Water is still 2' lower than last year's significant flooding and while airport road is flooded, airstrip itself is dry.

Alakanuk:

Water up 2' in last 24 hrs. and continues to rise. SEOC is in direct communication with community. **Nunam Iqua:**

Ice intact in front of town with water within riverbanks.

Fort Yukon Communities Snowmelt Flood Concern:

A Flood Watch is in effect for snowmelt flooding from the Porcupine River at Fort Yukon. There is concern for snowmelt flooding from Canada on the Porcupine River that could impact Fort Yukon this weekend. SEOC has been in contact with Fort Yukon and Canadian officials and is actively monitoring.

2024 Spring Flood Disaster

SEOC is actively assisting Kwethluk as they fully restore their community water system. They continue a boil water notice until samples are tested. ADEC completed field visits to Kwethluk and Napaskiak to survey for environmental concerns including oil spill, landfill inundation, and water systems. Incident will soon transition completely from response to recovery.

Akiak Power Disruptions:

SEOC conducted an in-person meeting yesterday with the community, tribal representatives, AEA, FEMA, and DCRA LGS to try and prevent a total power outage in Akiak and resultant infrastructure damage due to current temperatures.

Yesterday afternoon, SEOC received a local declaration of disaster emergency from the City of Akiak to assist in water system, transportation, and power generation issues.

The power outages have compromised the city water and sewer system, leaving the school unavailable as a shelter. SEOC has contacted Red Cross who has a shelter team standing by to support shelter operations in Akiachak or Bethel if requested by the city. YKHC is also ready to provide shelter space in Bethel, and SEOC has contacted the Bethel Armory if needed for sheltering over the weekend.

SEOC remains engaged with the community and all available agencies to find solutions to stabilize and repair this community.

2024 Spring Flood Disaster:

Kuskokwim Division:

Governor Dunleavy has declared a disaster for the Kuskokwim River communities in the Lower Kuskokwim and Yupiit Regional Education Attendance Areas in response to flooding. The disaster recovery Individual Assistance program, that provides grant funding to individuals and families with damaged to primary residence or essential personal property lost during the flooding, is now open for those in the declared area.

SEOC is actively assisting Kwethluk as they fully restore their community water system.




