Significant Issues:

Unalakleet Power Disruption-

SEOC was in contact with City of Unalakleet, and Unalakleet Valley Electric Cooperative (UVEC) all weekend. UVEC repaired second generator and reduced energy alert level to EEA 1. SEOC will continue to work with the city, community and UVEC to make sure the third genset is back in service and full power is restored.

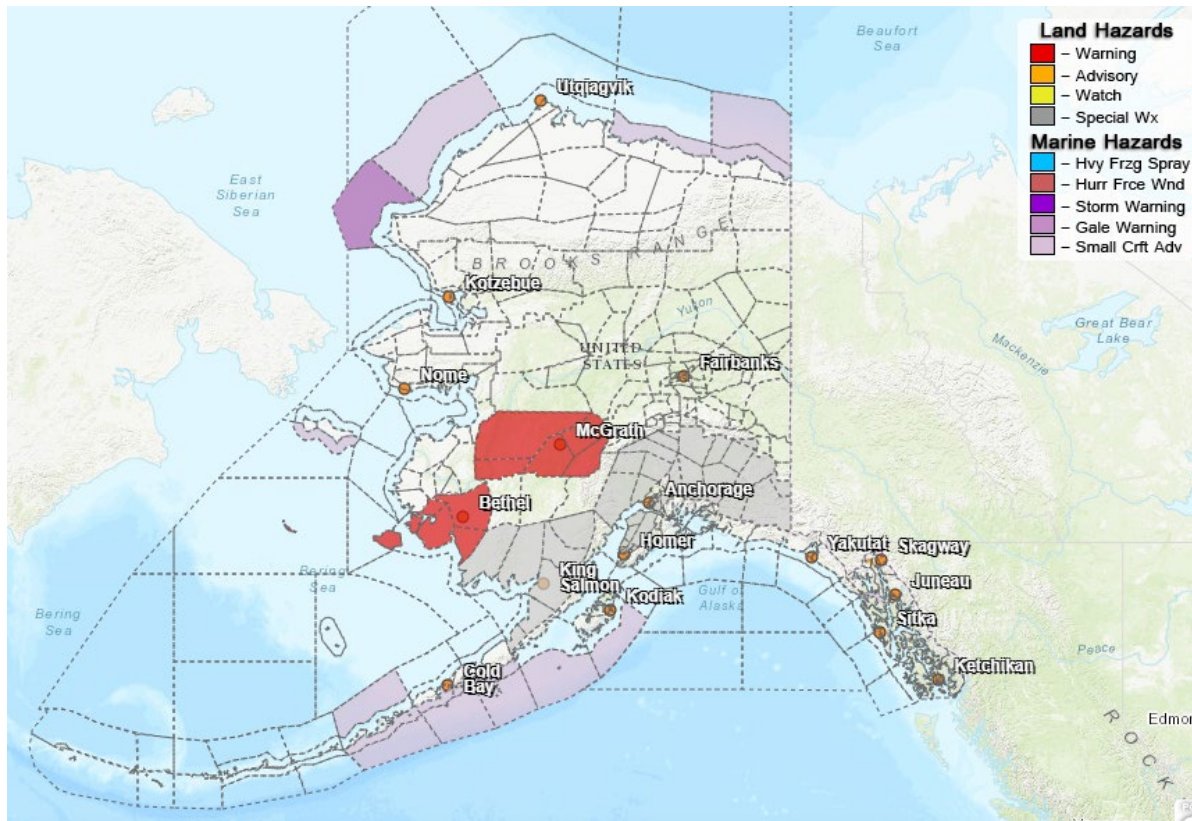
