Significant Issues:

Alaska Wildland 2024 Fire Season:

Division of Forestry contacted SEOC today to request the use of the Alaska National Guard Armory in Fairbanks as a mobilization center for incoming fire crew and resources. SEOC is actively monitoring wildland fires statewide and will be in contact with agency partners to ensure open lines of communication.

The Alaska Interagency Coordination Center upgraded the **Preparedness Level to 4** today. This is due to warm, dry weather. The levels range from 1 (minimal activity) to 5 (very high activity). See links below (page 2) for more information.



White Mountains, High Terrain South of the Yukon River, Fortymile Country, Tanana Flats, Two Rivers, Fairbanks Metro Area, Central Interior-in effect from 10am to 10pm Thursday for lightning.

South Slopes of The Central Brooks Range, Upper Koyukuk Valley, Dalton Highway Summits, Yukon Flats-in effect from 10am to 10pm Thursday.

Dense Smoke Advisory: Fairbanks Metro Area, Tanana Flats, Eielson AFB, Salcha-in effect until 4pm Thursday.

Flood Advisory:

Haines Borough and Klukwan-for snowmelt now in effect until 7pm Sunday. **Susitna Valley-**for snowmelt on the Swentna and Yentna Rivers until noon Thursday.
