## **Significant Issues:**

## McGrath Power Outage-

SEOC spoke with both the City Administrator and power operator in McGrath yesterday. Current power is restored, scheduled outages may occur due to repair of power lines. Contracted final power repair crews were anticipated to arrive yesterday evening. All local personnel are aware of extreme cold weather forecast. City has a contingency plan for emergency sheltering during the extreme cold weather.

#### **Cantwell Power Disruption-**

Power is 100% restored. Scheduled outages may occur due to repair of power poles damaged by avalanche.



**Valdez Maritime, Intermountain, and Continental**— Moderate below 1,500', Considerable above 1,500'.

Hatcher Pass- Moderate below 2,500', Considerable above 2,500'.
