

Southern Seward Peninsula Coast, Eastern Norton Sound and Nulato Hills, Yukon Delta Coast-water and ice along beaches through Monday night.

Fortymile Country, Delta Junction, Upper Chena River Valley, Tanana Flats, Eielson AFB and Salcha, Goldstream Valley and Nenana Hills, Chatanika River Valley, Two Rivers, Fairbanks Metro Area, Nenana, Northern Denali Borough- slick roads and sidewalks with falling temperatures today and tonight.

Winter Storm Warning:

Municipality of Skagway-in effect until 6am Tuesday.

Winter Weather Advisory:

Eastern Alaska Range South of Trims Camp- in effect until 3pm this afternoon.


Flood Advisory:

Summit Lake - Moderate below 1,000', Considerable above 1,000'. Turnagain Pass – Moderate below 1,000', Considerable above. Hatcher Pass- Considerable above 2,500', Low below 2,500. Valdez – Maritime – High above 1,500'. Valdez – Intermountain – High above 2,000'. Valdez – Continental – High above 2,000'.
