Significant Issues:

Port Heiden Generation Failure-

Lake and Peninsula Borough Emergency Manager contacted SEOC yesterday afternoon reporting that the community of Port Heiden had both generators fail leading toward a community wide outage. SEOC contacted AEA who was already actively working with the community, had a replacement generator in Anchorage ready to ship, and was supporting contracting for repairs. A lineman was in the community working on generator repair with remote guidance from AEA and had restored power late yesterday evening.

Borough Emergency Management reported that the school was ready as a shelter if needed. SEOC will remain actively engaged if further assistance is requested.

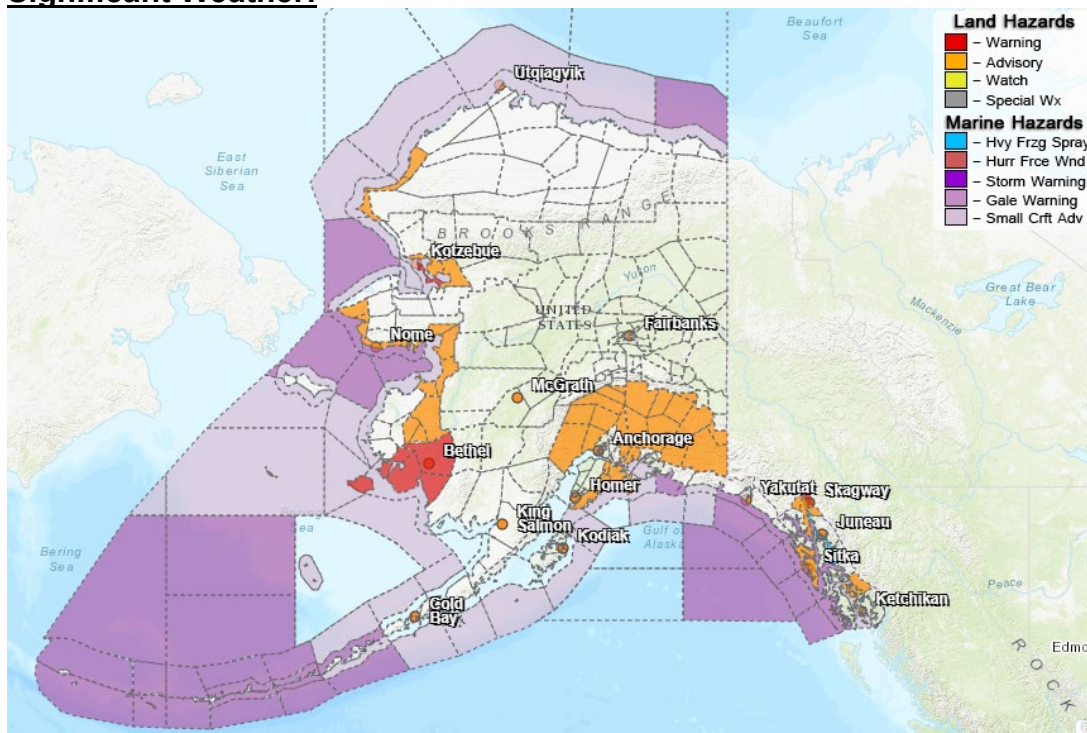

- **Municipality of Skagway**- in effect from 6pm this evening to 6pm Saturday.

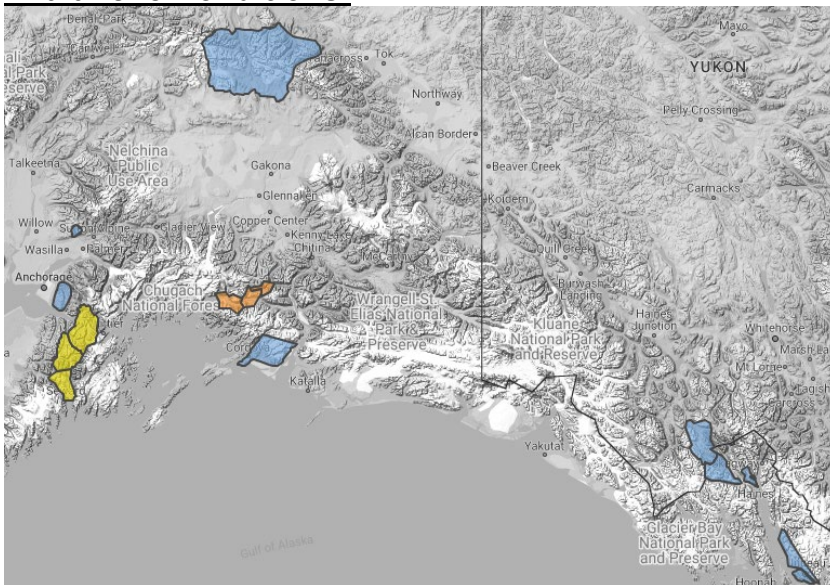
Air Quality Alert:

Summit Lake – Low below 1,000', Moderate from 1,000' and above.

Turnagain Pass – Low below 2,500', Moderate at 2,500' and above.

Seward and Lost Lake– Low below 1,000', Moderate from 1,000' and above.

Valdez Maritime, Intermountain, and Continental– Considerable at all levels.

Hatcher Pass- Moderate at all levels.
