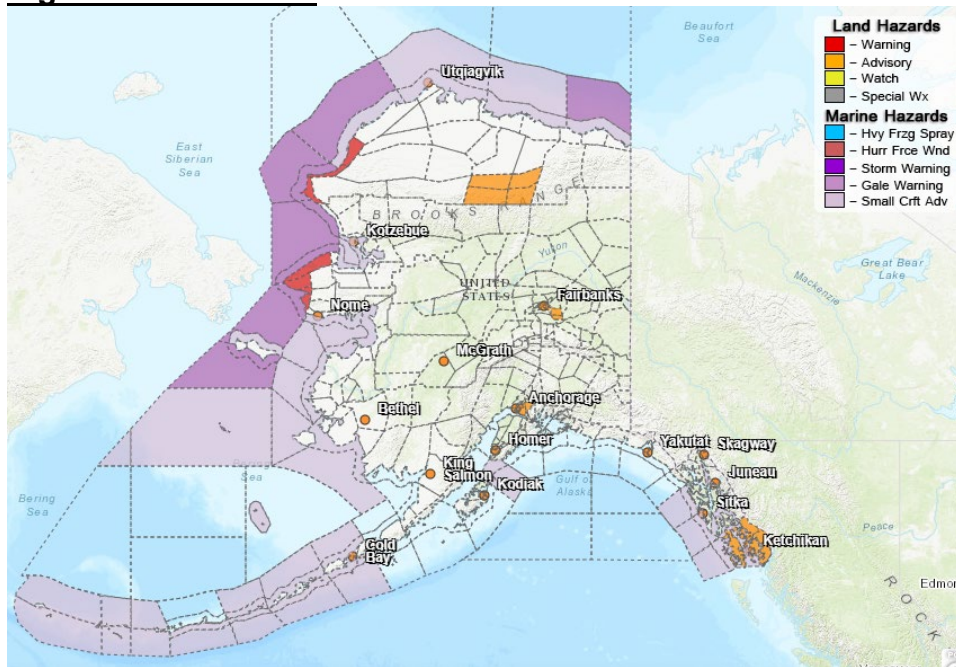

Dense Fog Advisory:

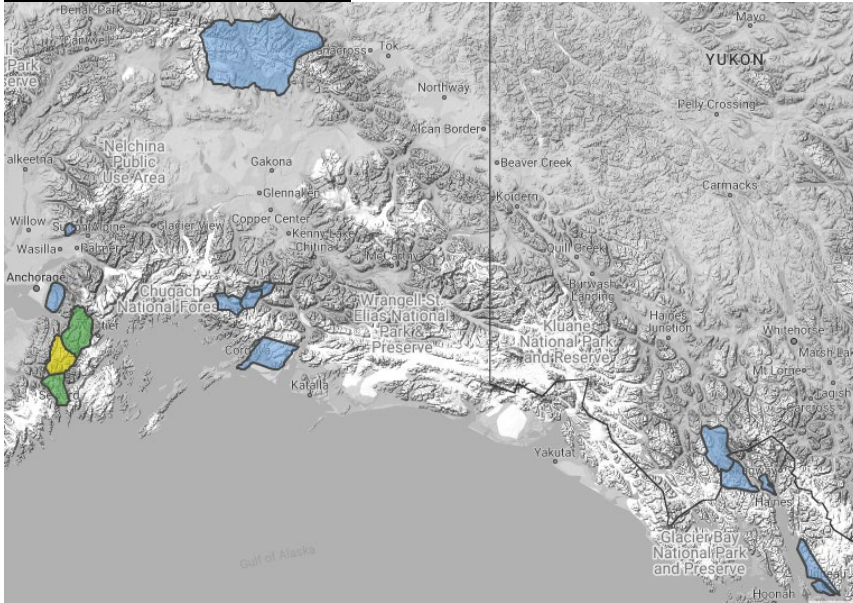
