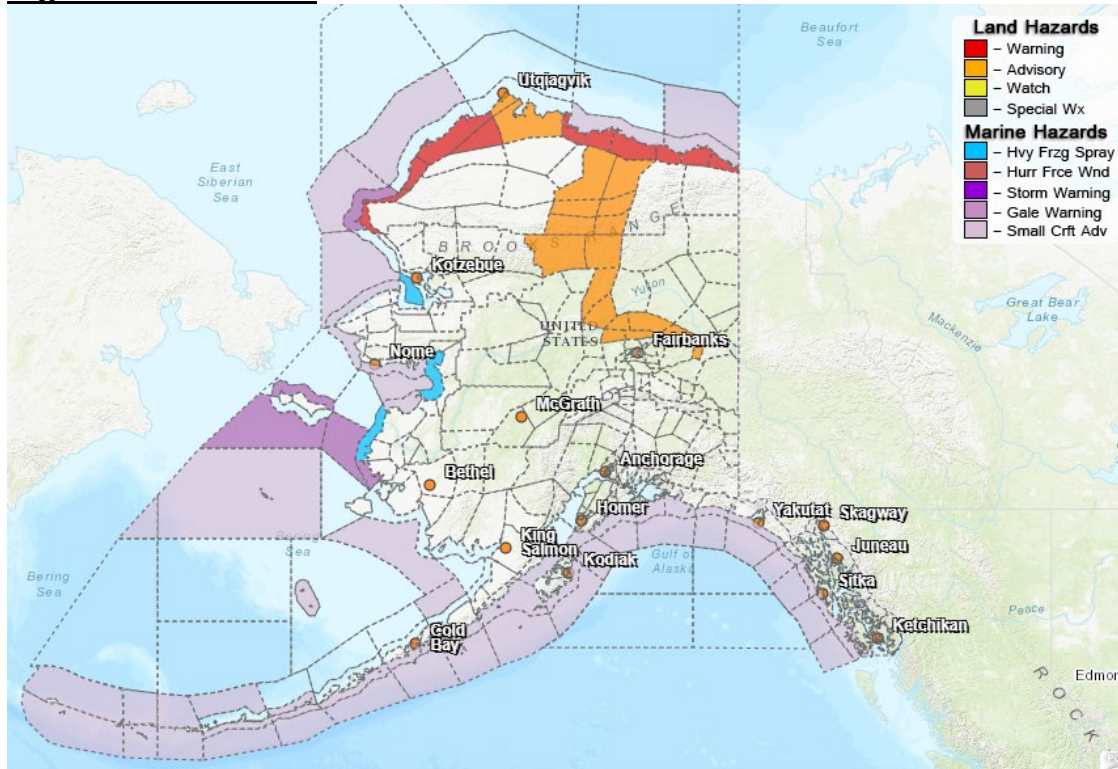

Winter Weather Advisory:

Winter Storm Watch:

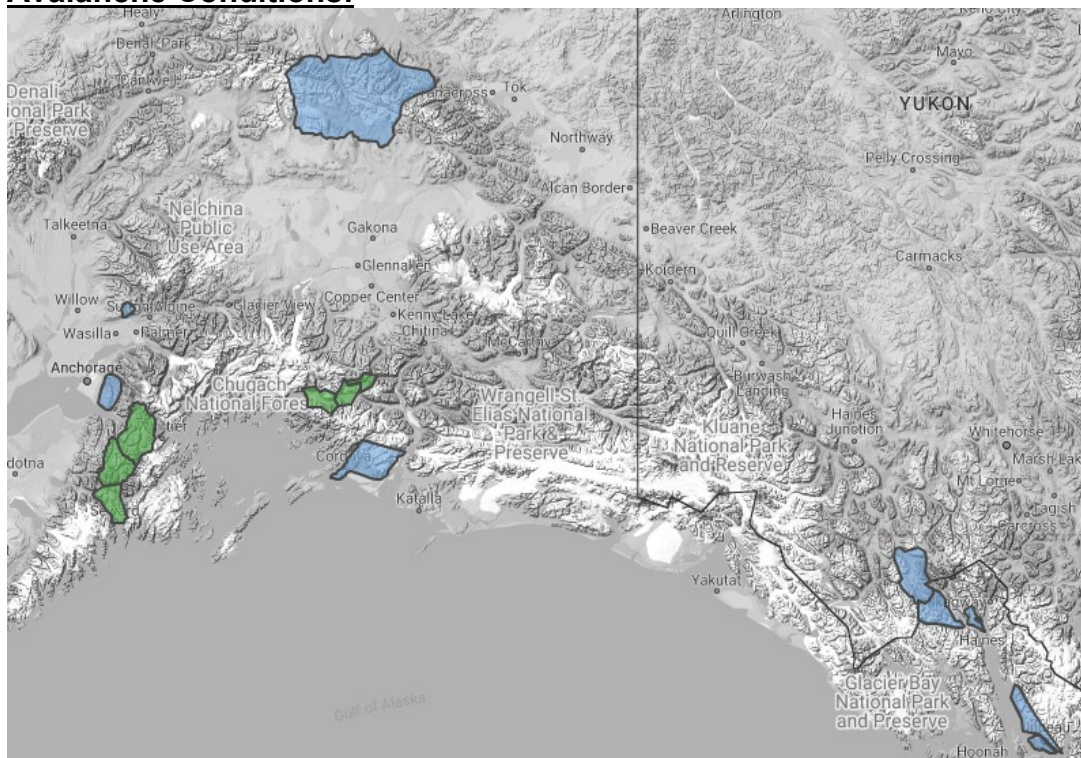
- **Central Beaufort Sea Coast, Eastern Beaufort Sea Coast-** remains in effect from Wednesday afternoon through Friday evening.
