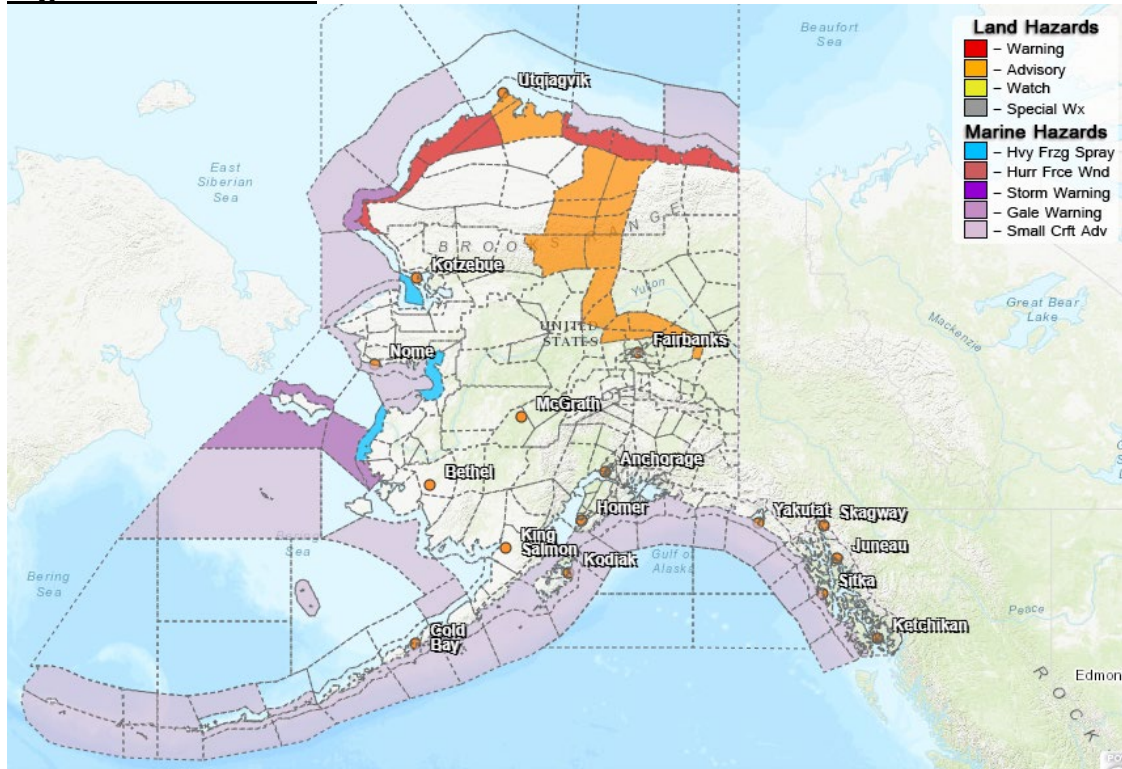

Blizzard Warning:

- **South Slopes of the Central Brooks Range-** Remains in effect from 3am Thursday to 3am Saturday.
- **Central Brooks Range-** Remains in effect from 9am Thursday to 3am Saturday.
- **Central Beaufort Sea Coast and Eastern Beaufort Sea Coast-** Remains in effect from 6am Thursday to 3am Saturday.
- **Western Arctic Coast and Northwest Arctic Coast-** In effect until 3am Saturday.

Winter Weather Advisory:

- **Central Arctic Plains, Dalton Highway Summits, White Mountains and High Terrain South of the Yukon River-** Remains in effect from 3am Thursday to 3pm Friday.

Winter Storm Warning:

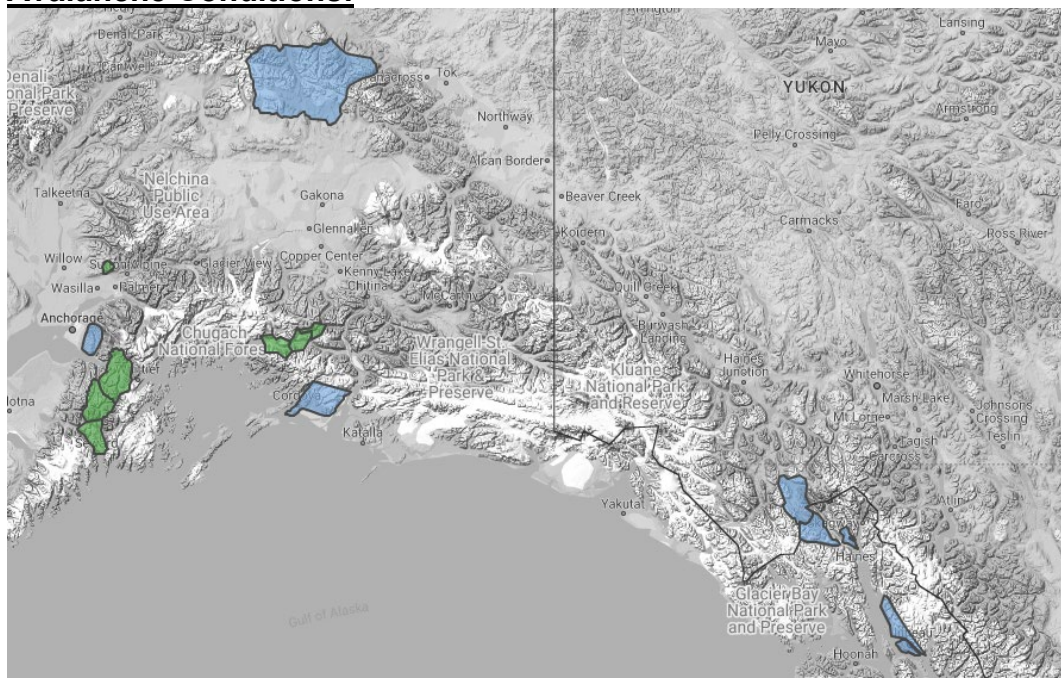
- **City and Borough of Yakutat-** Remains in effect from 9pm this evening to 9pm Friday.
