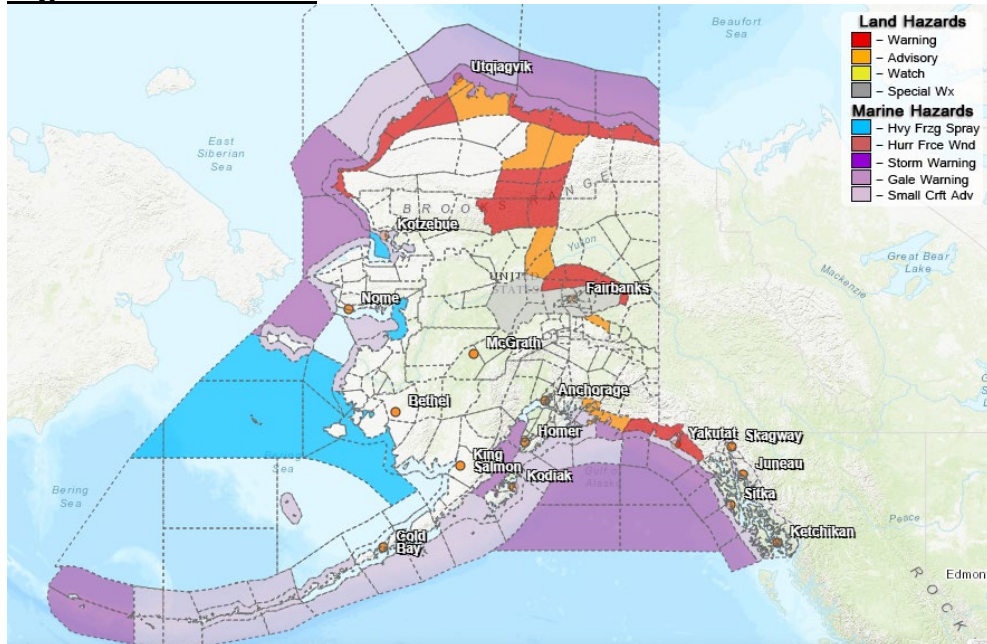

Special Weather Statement:

- **Upper Chena River Valley, Tanana Flats; Eielson AFB and Salcha, Goldstream Valley and Nenana Hills, Chatanika River Valley, Two Rivers, Fairbanks Metro Area, Nenana, Central Interior-blustery winds through Friday across the Interior.**

Blizzard Warning:

- **White Mountains and High Terrain South of the Yukon River-in effect until 3pm this afternoon.**
- **South Slopes of the Central Brooks Range, Central Brooks Range, Western Arctic Coast and Northwest Arctic Coast - in effect until 3am Saturday.**
- **Central Beaufort Sea Coast, Eastern Beaufort Sea Coast-from 6am this morning to 3am Saturday.**

Winter Weather Advisory:

Winter Storm Warning:

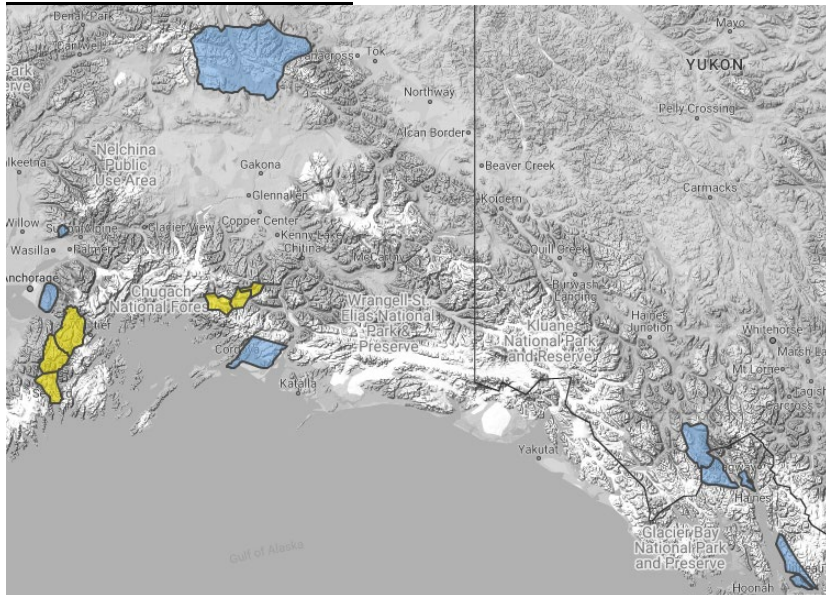
- **City and Borough of Yakutat- in effect until 9pm this evening.**
