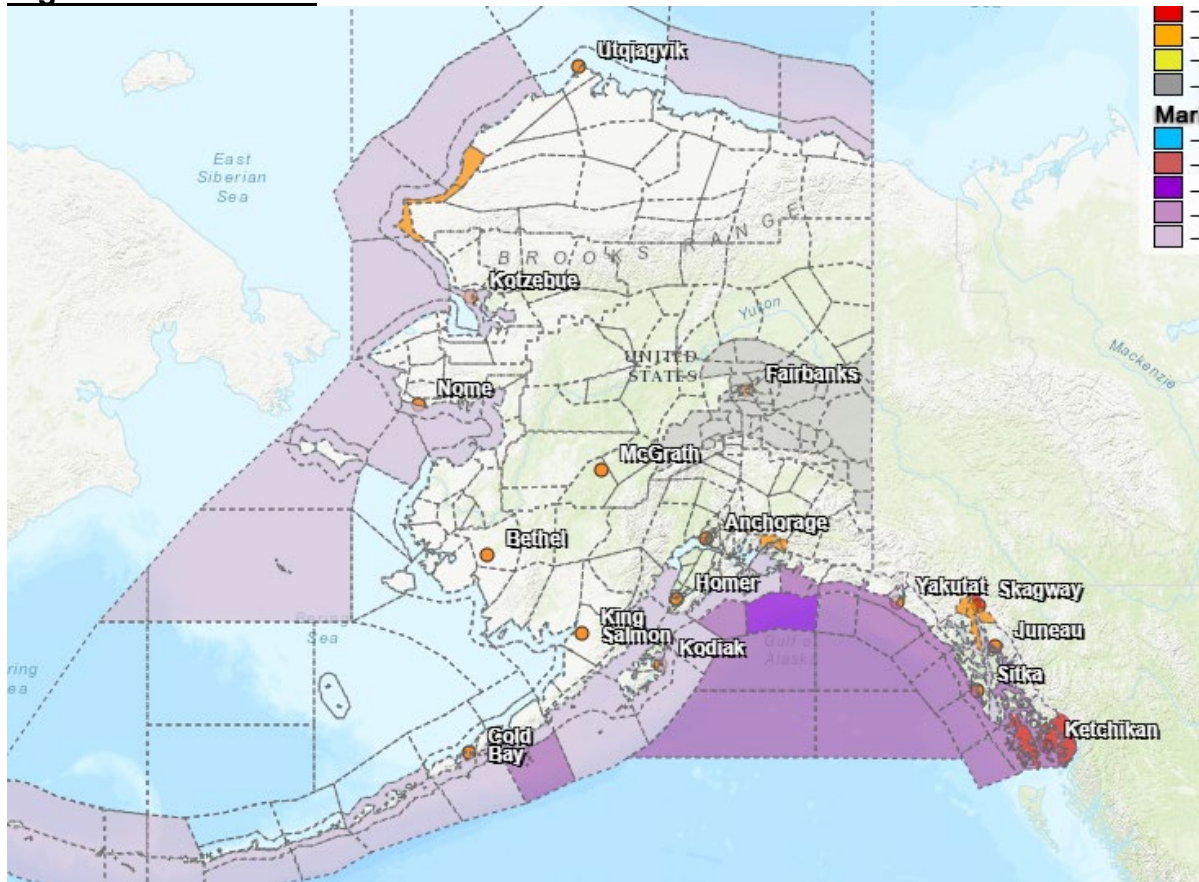

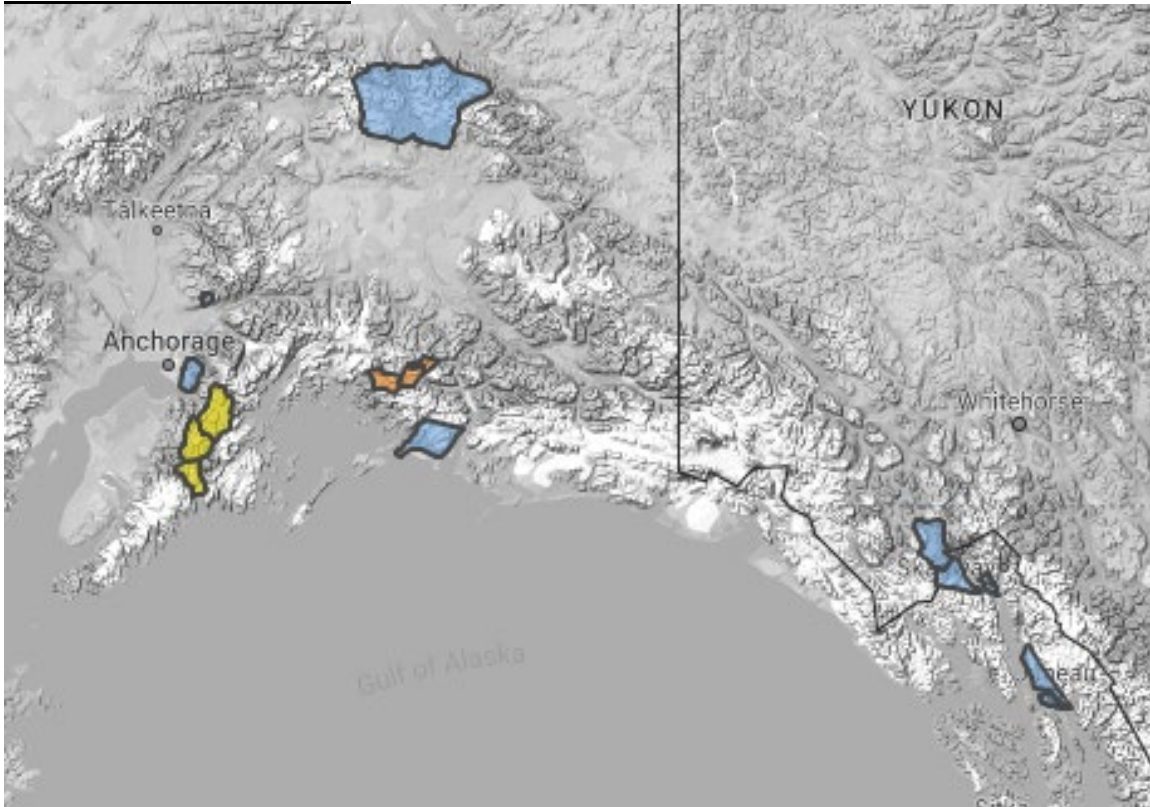

Valdez Maritime, Intermountain, and Continental – Considerable above 4000' to 2000'
Moderate below 2000'

Hatcher Pass –Low at all levels.
